I, William B. Black, do hereby state and declare as follows:

(U) INTRODUCTION

(C) I am the Deputy Director of the National Security Agency (NSA), an intelligence agency within the United States Department of Defense (DoD). Pursuant to the NSA's Order of Succession, I am also currently the Acting Director because the Director is outside the United States. As Acting Director, I am responsible for directing the NSA, overseeing the operations undertaken to carry out its mission and, by specific charge of the President and the Director of National Intelligence, protecting NSA activities and intelligence sources and methods. I have been designated an original TOP SECRET classification authority under Executive Order No. 12958, as amended. In the course of my official duties, I have been informed about this lawsuit, the issues raised by the Plaintiffs' claims and new facts relevant to this lawsuit.1

Negroponte, has asserted the 2 3 military and state secrets privilege and a statutory privilege over new facts related to a May 24, 4 2006 Order of the Foreign Intelligence Surveillance Court (FISC). 5 6 I have reviewed the FISC's Order and Director Negroponte's supplemental 7 declaration, and I agree with Director Negroponte that the disclosure of information related to the 8 9 FISC's Order would cause exceptionally grave damage to the national security. I also note that the 10 FISC has prohibited the disclosure of information related to the Order except pursuant to narrow 11 exceptions not applicable here. Accordingly, I support Director Negroponte's privilege assertions 12 and likewise assert the NSA's statutory privilege, set forth in section 6 of the National Security 13 Agency Act of 1959, Public Law No. 86-36 (codified as a note to 50 USC. § 402), over the same 14 15 information. 16 17 18
