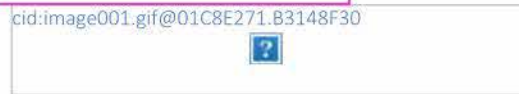
I'll be with Julie Kilbert, who will be observing and looking for ways to make the course better.
