<b>Performance Measure Description</b>	<p>DHS' Targeted Violence and Terrorism Prevention (TVTP) Grant Program has the core activity of establishing prevention capabilities at the local level. Additionally, the TVTP Grant Program has the core requirement of ensuring that the prevention capabilities established are sustained beyond the period of performance. To do so, DHS has created the performance measure “% of capabilities fully or partially sustained 1 year following the end of the period of performance” where “capabilities” refers to the number of projects by type funded under that award. This measure aims to assess grantees 1 year following the end of their period of performance in order to ascertain the % of capabilities fully or partially sustained following the expiration of the DHS funding.</p> <p>Due to the diversity in the types of projects funded within DHS TVTP Grant Program (refer to the <a href="#">FY21 TVTP NOFO</a>, Appendix B for a description of the 8 project types), the specific details of the “capabilities” will be contextualized within the assessment to the goals and objectives for that particular project type. For DHS' FY20 TVTP Grant Program 42 capabilities will be assessed. For DHS' FY21 TVTP Grant Program 82 capabilities will be assessed.</p>

<p><b>Verification and Validation (V&amp;V):</b></p>	<p>CP3 Grants analysts will assess each of the funded capabilities through interviews and by reviewing documents and data concerning the previous year and comparing it to the final report submitted by the recipient. Two grants analysts will independently review the information and arrive at a consensus as to whether the capability is not sustained, partially sustained, fully sustained, or insufficient data. CP3 Policy and Research will review the conclusion and underlying information to validate the results.</p>
<p><b>Scope (Range) of Data</b></p>	<p>The unit of analysis for CP3’s TVTP Grant Program Performance Measure is the number of capabilities sustained one year following the period of performance of the grant. The number of capabilities is determined by the number of tracks funded within the TVTP Grant Program’s “Promising Practices” Track. Grantees can apply for DHS funding to implement a program inclusive of one or more of the eight different tracks outlined below:</p> <ol style="list-style-type: none"> <li>1. Raising Societal Awareness; 2. Media Literacy and Online Critical Thinking Initiatives; 3. Civic Engagement; 4. Youth Resilience; 5. Threat Assessment and Management Teams; 6. Bystander Training; 7. Referral Services; 8. Recidivism Reduction and Reintegration</li> </ol> <p>The population for this dataset includes the entirety of grant programs within the “Promising Practices” track of the TVTP Grant Program for any TVTP grant program that has been completed for 1 year. The attribute of this dataset being assessed is “sustainability” -- whether or not the capability or capabilities the grantee was funded to implement have been sustained. For the purposes of this performance measure and due to resource constraints, this assessment of sustainability is limited to a singular analysis occurring one year following the end of the period of performance. Each capability will be assessed on whether the capability was (a) fully sustained; (b) partially sustained; (c) not sustained or (d) insufficient data. CP3 also funds grants within an “Innovation” track which is outside the scope of this performance measure.</p>

<p><b>Data Source</b></p>	<p>The data for this performance measure will be attained from each recipient. The data collected from each recipient will be stored within the CP3 Filing Server and will be compiled there on an annual basis by the CP3 Grants Team. The CP3 Grants team will also be responsible for managing the data and reporting on the results, in coordination with CP3’s Policy and Research Section (PRS).</p>
<p><b>Data Collection Methodology</b></p>	<p>The CP3 Grants Team will reach out to individual grantees on an annual basis to collect data on the number of capabilities sustained one year following the end of the period of performance. Grantees will be required to respond within 60 days enabling adequate time to gather any data that is not readily available at the time of receipt. Grantees will be reminded during the period of performance that their agreement to respond in full to this data request is a condition of their award. This requirement – to provide data following the end of the period of performance -- is included within the Notice of Funding Opportunity (see section F(2)(g) “Evaluation” on page 25 of the FY22 NOFO).</p>

<b>Results Validation (Reliability Check)</b>	The data received will be checked for reliability by the CP3 Grants Team, inclusive of both Program Analysts and the Grants Team’s Associate Director. This process will be implemented in coordination with CP3’s Policy and Research Section (PRS) and the support of DHS’ Science and Technology Directorate (S&T) as appropriate.
