1. MISSION HAS RECEIVED A COMMUNICATION FROM SPECIAL RAPPORTEUR ON EXTRAJUDICIAL, SUMMARY OR ARBITRARY EXECUTIONS ASMA JAHANGIR DATED NOVEMBER 15, 2002, ADDRESSED TO THE SECRETARY OF STATE. THE LETTER IS IN REFERENCE TO THE "SIX MEN ALLEGEDLY KILLED WHILE TRAVELING IN A CAR ON 3 NOVEMBER 2002 IN THE REPUBLIC OF YEMEN." THE SPECIAL RAPPORTEUR UNCLASSIFIED

THE COMMUNICATION STATES:

"I HAVE THE HONOUR TO ADDRESS YOU IN MY CAPACITY AS SPECIAL RAPPORTEUR ON EXTRAJUDICIAL, SUMMARY OR ARBITRARY EXECUTIONS, PURSUANT TO COMMISSION ON HUMAN RIGHTS RESOLUTION 2001/45.

"AS YOU KNOW, IN THE ABOVE-MENTIONED RESOLUTION THE COMMISSION ON HUMAN RIGHTS, INTER ALIA, 'REITERATES THE OBLIGATION OF ALL GOVERNMENTS TO CONDUCT EXHAUSTIVE AND IMPARTIAL INVESTIGATIONS INTO ALL SUSPECTED CASES OF EXTRAJUDICIAL, SUMMARY OR ARBITRARY EXECUTIONS, TO IDENTIFY AND BRING TO JUSTICE THOSE RESPONSIBLE, WHILE ENSURING THE

UNITED STATES DEPARTMENT OF STATE REVIEW AUTHORITY: ARCHIE M BOLSTER DATE/CASE ID: 23 JUN 2011 201000373

RIGHT OF EVERY PERSON TO A FAIR AND INTELL AND TO GRANT ADEQUATE COMPENSATION TO THE VICTIMS OR THEIR FAMILIES AND TO ADOPT ALL NECESSARY MEASURES, INCLUDING LEGAL AND JUDICIAL MEASURES IN ORDER TO BRING AN END TO IMPUNITY, TO PREVENT THE RECURRENCE OF SUCH EXECUTIONS.' FURTHERMORE, THE COMMISSION 'REQUESTS THE SPECIAL RAPPORTEUR, IN CARRYING OUT HER MANDATE: (...) (B) TO RESPOND EFFECTIVELY TO INFORMATION WHICH COMES BEFORE HER, IN PARTICULAR WHEN AN EXTRAJUDICIAL, SUMMARY OR ARBITRARY EXECUTION IS IMMINENT OR SERIOUSLY THREATENED OR WHEN SUCH AN EXECUTION HAS OCCURRED.'

"IN THIS CONNECTION, I WOULD LIKE TO DRAW THE ATTENTION OF YOUR EXCELLENCY'S GOVERNMENT TO INFORMATION WHICH HAS COME TO MY ATTENTION RECENTLY, WHICH REPORTS THAT SIX MEN WERE ALLEGEDLY KILLED WHILE TRAVELING IN A CAR ON 3 NOVEMBER 2002 IN THE REPUBLIC OF YEMEN BY A MISSILE LAUNCHED BY A UNCLASSIFIED

US-CONTROLLED PREDATOR DRONE AIRCRAFT. ACCORDING TO THE
INFORMATION COLLECTED, ONE OF THE PERSONS IN THE CAR WAS
ALLEGEDLY SUSPECTED TO BE A SENIOR FIGURE OF THE AL-QAEDA
ORGANIZATION. THE STRIKE WAS REPORTEDLY CARRIED OUT WITH THE
COOPERATION AND APPROVAL OF THE GOVERNMENT OF THE REPUBLIC OF
YEMEN.

"WHILE I IN NO WAY WISH TO DRAW CONCLUSIONS BASED ON THE INFORMATION SO FAR COLLECTED, I WOULD LIKE TO REFER YOUR EXCELLENCY'S GOVERNMENT TO HE FUNDAMENTAL PRINCIPLES SET FORTH IN THE UNIVERSAL DECLARATION OF HUMAN RIGHTS AND THE INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS.

ARTICLES 3 AND 6 OF THESE INSTRUMENTS, RESPECTIVELY, PROVIDE THAT EVERY INDIVIDUAL HAS THE RIGHT TO LIFE AND SECURITY OF THE PERSON, THAT THIS RIGHT SHALL BE PROTECTED BY LAW AND THAT NO ONE SHALL BE ARBITRARILY DEPRIVED OF HIS OR HER LIFE. THE INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS FURTHER PROVIDES THAT THE RIGHT TO LIFE CAN IN NO CIRCUMSTANCES BE DEROGATED.

"I AM CONCERNED THAT SHOULD THE INFORMATION RECEIVED BE ACCURATE, AN ALARMING PRECEDENT MIGHT HAVE BEEN SET FOR EXTRAJUDICIAL EXECUTIONS BY CONSENT OF GOVERNMENTS. I WISH TO ACKNOWLEDGE THAT GOVERNMENTS HAVE A RESPONSIBILITY TO PROTECT THEIR CITIZENS AGAINST THE EXCESSES OF NON-STATE ACTORS OR OTHER AUTHORITIES BUT THESE ACTIONS MUST BE TAKEN IN ACCORDANCE WITH INTERNATIONAL HUMAN RIGHTS NORMS.

"I WOULD GREATLY APPRECIATE TO RECEIVE COMMENTS FROM YOUR EXCELLENCY'S GOVERNMENT WITH REGARD TO THE INFORMATION LISTED

ABOVE, AND WOULD APPRECIATE IF A REPTY WOULD STFT ARDED UNCLASSIFIED
