NARRATIVE

On 08-25-2020, I, Officer Ryan Hill #557, was on normal patrol operating squad #3338 in full KPD uniform with Officer Held #549. Officers were in the 6300 block 22nd Ave maintaining scene security in regards to the civil unrest and continued need for police presents due to multiple buildings on fire from the overnight riots.

While on scene, I observed two M/W subjects in a verbal altercation on the E/S of 22nd Ave. Officers maintained a distance as the altercation was in the middle of a group of onlookers and possible agitators. As I was maintaining a visual on the subjects, one of the individuals, later identified as Andrew Lininger, who was wearing a maroon hooded sweatshirt and gym shorts, began spitting in the face of the other subject. The second subject did not react or retaliate but the verbal altercation continued.

As I started to move closer to their location, I observed Lininger walk over to a evergreen tree and reach for an object on the ground. After he picked up the object, I identified it as a very large rock, approximately 12" in diameter. I then observed Lininger quickly move towards the other subject and make a motion with the rock indicating that he was attempting to target and throw the rock at the subject.

Just prior to throwing the rock, the subject held back for an unknown reason but started angling around to the side of the subject he was in an altercation with. At that moment, I engaged Lininger and decentralized him to the ground preventing him from carrying out his attempt at throwing the large rock at the other subject.

Once on the ground, Lininger was instructed by multiple officers that he was under arrest and put his hands behind his back. However, Lininger quickly became resistive and kept trying to free his hands and well as tuck them underneath his body to prevent officers from securing him in handcuffs. The entire time officers were attempting to apprehend Lininger, we were being surrounded by subjects in the crowd, some actively yelling at officers for our actions.

Lininger was eventually secured in handcuffs and assisted to his feet. At that point, officers began escorting Lininger towards our squad and away from the crowd. While walking, Lininger tried multiple times to drop to the ground to prevent officers from escorting him to pull free from officers hold. I then rapped my arm under his and held on to his should in order to effectively escort lininger to the squad.

After arriving at the squad, Officers adjusted Lininger's handcuffs for proper fit and double locked them. Lininger was then secured in the back of the squad and transported to the Kenosha jail without further incident.

Custody of Lininger was turned over to Kenosha Jail correctional officers and an arrest report was completed. Photos of the rock that Lininger process were taken and later uploaded to the KPD server. The identity of the second subject was not obtained.

This concludes officers involvement in the incident.
