NARRATIVE

On 08-26-20 at approximately 0041hrs I, PO Clayton #604 was on patrol in full Kenosha PD uniform. I responded to a suspicious call in the 7700blk of 18th Ave.

observed a dark colored older moped pulled up. Steven said that the operator of the moped appeared to be a male, was wearing dark clothing, and had on a dark helmet. Steven stated it was dark outside and he couldn't see any more details. Steven said that the male dropped a back pack off in the parkway on the west side of the roadway and then left S/B. Steven stated he went to look at the back pack and saw a golf club so he stayed away and called the Police.
I observed a black in color sling style backpack with a grey scion logo. Inside of the backpack I observed an old wooden baseball bat and a metal golf club. I also observed a bill of sale for a moped. On the bill of sale it states that the seller is a Blake Kreuser who resides at The buyer's name is hard to read due to bad handwriting and it appears to me that the name is Zachery Manogo-Dodge who resides at The Photographs were taken of the above items and they were secured and logged into evidence locker #004 as found property.
Dispatch advised that they did not have anyone with the first name Zachery living at The closest in-house records I found would be a Zachary Manon with a last known address in Salem. It is unknown if he is involved.
This ends my involvement in the case at this time.
