**NARRATIVE**

S - Irby, Naganda J. (DOB: [REDACTED] 2000)

Summary of events:

On 08/25/2020 at approximately 1:35am, Deputies responded to Target (9777 76<sup>th</sup> Street) for a report of an unknown amount of people trying to break into the front doors of the closed. Upon arrival, I observed a male subject exit the store through the front door. The subject was taken into custody and subsequently transferred to Pleasant Prairie Police custody.

Narrative:

On 08/25/2020 at approximately 1:35am, I Deputy Treiber #348 along with Deputy Conlon #340 were on patrol in fully marked KSD squad #327. While on patrol, we were dispatched to Target (9777 76<sup>th</sup> Street) for a report of an unknown amount of people trying to break into front doors of the store. Upon arrival, I observed a black male subject exiting a hole in the front glass door; which was shattered. The male subject had a green backpack with I exited the squad and the male subject attempted to flee from me by running west along front of the store. After a short foot pursuit, I was able to catch the male subject and detain him.

Deputy Conlon #340 performed a pat down for weapons of the male subject and no weapons or contraband were located on his person. Initially the male subject would not provide me his name because he stated that he did not want to go to jail. After speaking with him for a few minutes, he verbally identified himself as Naganda J. Irby (DOB: [REDACTED] 2000). I notified Pleasant Prairie Officer Dutter #198; who was the officer taking lead on this investigation. I transferred custody of Naganda to Officer Dutter and secured him in the back of Officer Dutter's squad car without further incident.
