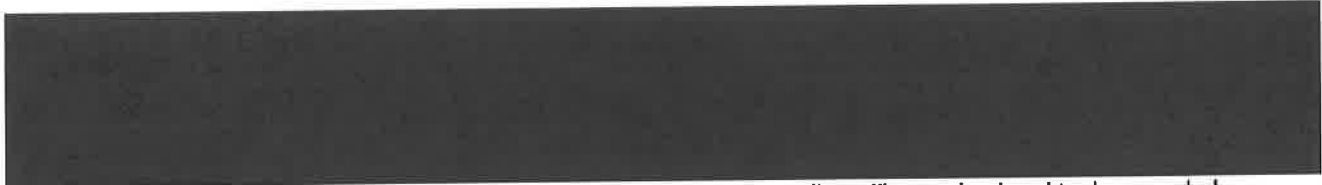
Kenosha Protests August 25th

My assignment was TEMS (tactical emergency medical services) for the Sauk County ERT (Emergency Response Team), I rode in the bearcat armored vehicle with 7 other team members. I remained in the vehicle during the incident except for medical evaluation of one female National Guard member that had been pulled from the field force line back into the park by the courthouse. She was determined to be stable and the two guardsman with her were instructed to assist her to a designated rescue vehicle that was also in the park. We then proceeded down the street to assist with dispersing the large crowd that had gathered near a gas station. We were then ordered back to the park, we were told by a officer that armor was needed to stage on the NW corner of the park, we arrived at that location to find a field force group that was taking a break as there were no protesters in that location. Within minutes of taking our own personal break and dismounting the bearcat, we were reassigned back to a location approximately half a block north of the gas station where the large crowd gathered. We staged at that location for a period of time and observed multiple persons with "military" style rifles on the west side of the street near a business that had been boarded up. I then observed these persons start running south past the gas station. After only a few seconds of that observation, gun shots were heard through our bearcat intercom system that has a microphone located in the driver's side of the vehicle. [REDACTED]

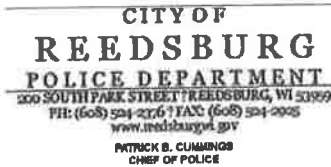

I waited with the West Allis Team until a Kenosha police officer arrived and took my verbal statement. Once we were released, I phoned my commander Matt Burch and debriefed him. He instructed me to find a way back to my team in the bearcat. The West Allis team drove me back to the courthouse park where I was able to rejoin my team. From that point on we staged near the park until we were released back to staging at the school.

BACKGROUND

On Tuesday 08-25-20 the Sauk County Emergency Response Team was requested and responded to the city of Kenosha to assist in response to civil unrest in the city where the city was experiencing rioting, looting and damage to property.

INFORMATION

On Tuesday 08-24-20 Sauk County ERT members were requested to respond to the city of Kenosha to assist with civil unrest occurring in the city of Kenosha. Sauk County ERT had previously responded to the city of Kenosha on Sunday 08-23-20 and we were deployed to provide security to fire department personnel as they put out several fires in the city. Sauk County ERT also responded to the city of Kenosha on Monday 08-24-20 where ERT assisted in controlling the civil unrest. During this incident law enforcement personnel and equipment were struck with objects such as rocks, bricks and fireworks. ERT members met at the Sauk County Law Enforcement Center and departed for the city of Kenosha at approximately 4:30 P.M. ERT members arrived in the city of Kenosha and staged at the staging area (Mary D Bradford High School).

Sauk County ERT was split into two teams (field force team and rescue vehicle operation) and I was assigned as a team leader to the rescue vehicle operation. Also assigned to rescue vehicle operation was Detective Pointon (driver), Sgt. Gilbert (navigator), Detective Spears (chemical munitions), Deputy Schlough (chemical munitions), Detective Oakeson, Deputy Stoddard and Paramedic Willer (TEMS). Due to the civil unrest chemical munitions were stored in the rescue vehicle and the LRAD (long range acoustic device) was set up on the rescue vehicle. We were assigned to the area of 56th St. and Sheridan St. and when we were a few blocks away from this location we placed the skip round shield on the passenger side of rescue vehicle. This was done because the prior night Waukesha's rescue vehicle was disabled after a firework was thrown at the rescue vehicle and exploded underneath the rescue vehicle.

We arrived on Sheridan St. at 56th St. and a crowd began to gather in the area. A large crowd was gathered in the park across from the courthouse on 56th St. and while on Sheridan St. items such as bottles and bricks were thrown at and struck our rescue vehicle. A green laser was aimed at our rescue vehicle. The crowd appeared to be agitated with our presence with the items being thrown, yelling at the rescue vehicle and body gestures of the crowd of flipping us off and waving arms frantically at us. Several subjects also walked around and within a few feet of the rescue vehicle as were in position.

The Kenosha County rescue vehicle responded to in front of the courthouse on 56th St. and accessed this by driving through the park. As they drove through the park I observed this rescue vehicle being struck with numerous objects thrown by the crowd. Shortly after this the Kenosha County rescue vehicle was in position in front of the courthouse we were requested to respond to in front of the courthouse as well. We began driving on Sheridan Rd and then turned into the park and during this time the rescue vehicle's emergency red and blue lights were activated along with the audible siren. As we turned into the park most of the people in the crowd dispersed and moved out of the way while others ran up to and beside the rescue vehicle. The rescue vehicle was struck with numerous objects to include bricks, rocks, bottles and fireworks. While driving in the park a subject stood in front of the rescue vehicle which caused the rescue vehicle to have to stop. The subject refused to move and commands were giving over the LRAD for

the subject to move and the subject refused to move and stood directly in front of the rescue vehicle. We requested the Kenosha County rescue vehicle attempt to move the subject by deploying less lethal munitions, but they were out of position and unable to do so. The rescue vehicle continued to be heavily struck by objects thrown by the crowd. Our rescue vehicle slowly inched forward and the subject eventually moved out of the way and we were able to position the rescue vehicle in front of the courthouse on 56th St.

While at this position the crowd continued to throw objects which included rocks, bricks, bottles, fireworks and other hard objects at our rescue vehicle and struck our rescue vehicle. I estimated the crowd at the park to be approximately 400-500 people. Announcements were made by Sgt. Gilbert over the LRAD system to the crowd to disperse and to leave the park. Announcements were also made by other rescue vehicles to disperse, to stop throwing items and were in violation of a curfew that was in place. The crowd did not obey any of these commands and continued to throw items to include fireworks at field force personnel and rescue vehicles.

We requested to use the LRAD system to disperse the crowd and command gave us permission to utilize the LRAD system. The LRAD system was activated and the crowd began to move back from field force personnel, but the crowd did not disperse entirely and continued throwing items at field force personnel. Throughout our deployment at this location we activated and used the LRAD system in attempt to disperse the crowd and stop any further civil unrest. The LRAD system was deployed for no longer than 25 minutes at a time and would be turned off for periods of time and would only be activated again when the crowd became more uncivil and violent.

Announcements were made if these actions did not cease that chemical agents would be introduced to the crowd. Items continued to be thrown at field force personnel and chemical munitions were deployed into the crowd from our rescue vehicle and other rescue vehicles on scene. Detective Spears deployed these chemical agents from the turret of our rescue vehicle and deployed approximately the following: 10 OC/CS 40 mm ferret rounds deployed by the 40 mm chemical munition launcher, 4 riot control CS chemical munitions deployed by hand, 2-4 instantaneous blast OC chemical munitions deployed by hand. Deputy Stoddard and I also deployed a total of 8 (4 each) hand held chemical munitions from the rear of the rescue vehicle. Deputy Stoddard and I opened the rear doors of the rescue vehicle, stepped out of the rescue vehicle and remained by the door and deployed the chemical munitions by hand. This was a combination of riot control CS, instantaneous blast OC, and flameless tri chambers. All ferret rounds were accountable when deployed and were directed into the ground, curb or tree bank in front of the crowd. The hand deployment of chemical munitions were deployed upwind of the crowd to use the wind at the fullest extent to safely disperse the crowd.

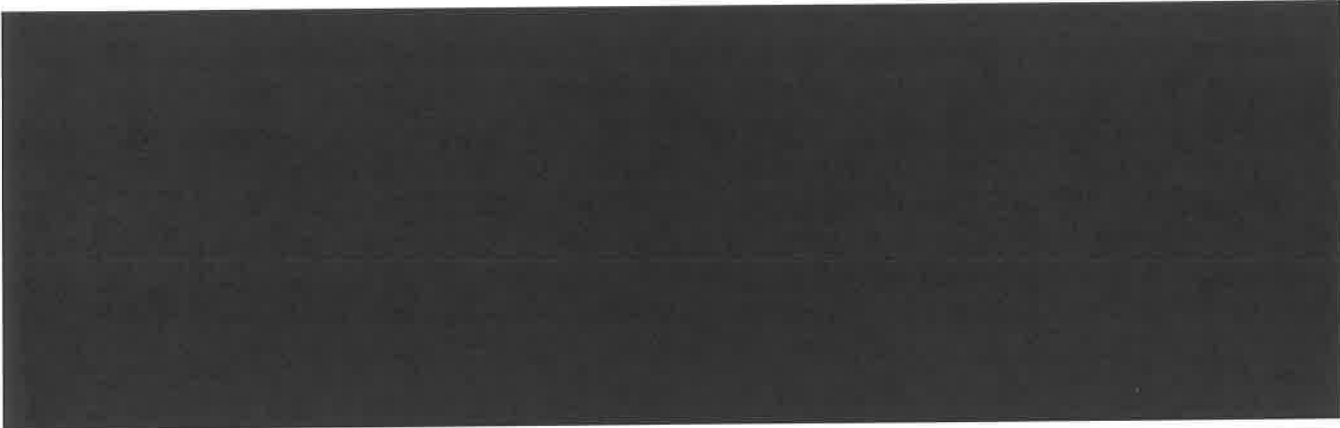
While attempting to deploy chemical munitions from the turret Detective Spears had to quickly shut the turret at times to prevent from being struck by objects being thrown such as rocks, bricks and fireworks. Deputy Stoddard and I also had to retreat quickly back into the rescue vehicle at times to prevent from being struck by items. Chemical munitions were directed in the area of crowd members who were throwing items such as rocks, bricks and fireworks. I observed the crowd begin to use barricades and create shields using umbrellas, dumpsters, street signs and other objects in order to advance closer to field force personnel. The crowd also utilized a human shield tactic where people would deliberately stand in front of a group who were launching or throwing objects.

A male subject wearing a hard hat approached the Kenosha County rescue vehicle and stood in front of the rescue vehicle and then began reaching in front of the rescue vehicle. It appeared the male subject was attempting to damage or disable the rescue vehicle or possibly light the rescue vehicle on fire. Sgt. Gilbert gave the subject commands over the LRAD system to move away from the rescue vehicle, but the subject did not comply and continued to stand in front of the rescue vehicle and manipulate his hands and arms in front of the rescue vehicle. Deputy Schlough deployed three 40 mm sponge rounds utilizing the 40 mm chemical munitions launcher from the turret of our rescue vehicle. The first sponge round did not strike the subject while the second round struck the subject on his left side in the mid-section area of his torso, but the subject remained in front of the rescue vehicle. The third sponge round struck the subject in the same area as the second sponge round and the subject then moved away from the Kenosha county rescue vehicle.

The crowd in the park did not disperse and our rescue vehicle along with other rescue vehicles and field force operations moved toward the park and continued to use the LRAD system and deployed chemical munitions and the crowd began to disperse the park. Our rescue vehicle continued to be struck by objects as we attempted to disperse the crowd. The crowd dispersed from the park and we positioned our rescue vehicle in the park and held a position there along with field force operations on the ground. While dispersing the crowd a field force member from the ground needed medical attention and Paramedic Willer assessed the field force member near the rear of our rescue vehicle. During this time we also removed the skip round shield from the side of the rescue vehicle and placed it inside the rescue vehicle.

The crowd began to assemble on Sheridan St. near 57th St. in the roadway. Several announcements were made for the crowd to leave and disperse, but they continued to remain in the street. Several rescue vehicles including our rescue vehicle began driving south on Sheridan St. and the crowd dispersed. Our rescue vehicle along with 4-5 other rescue vehicles proceeded south on Sheridan St. and stopped on Sheridan St. at 60th St. While driving south on Sheridan St. there were subjects standing and walking on the sidewalks and street, but they were not congregating in one large group. Our rescue vehicle would periodically be struck with objects such as rocks, bricks and bottles.

As previously stated we stopped and positioned ourselves on Sheridan St. at 60th St. with about 4 other rescue vehicles. A crowd of approximately 50 people began to congregate and assemble in the street and parking lot of a gas station located at the corner of Sheridan St. and 60th St. and we continued to monitor the crowd. At one point a female subject from the crowd squared herself up to the front of our rescue vehicle and from about 20 yards away threw a brick at our rescue vehicle. The brick struck the front driver's side windshield and damaged the windshield by chipping the windshield. Shortly after this our rescue vehicle moved back (north) approximately one block and continued to monitor the crowd from this position along with the other rescue vehicles.



We were at this location briefly and while there we observed a car on fire in the parking lot of a business on the corner of Sheridan St. at 63rd St. A crowd began to gather in this area and we monitored the area and crowd and waited for any fire response to provide security. We were informed by command we could depart the location and responded back to the area of the courthouse. We remained in this area and Paramedic Willer met us back at this location and we stayed in the area until command advised we could return to the staging area. No members from the rescue vehicle operation were injured and the rescue vehicle sustained damage from being struck by numerous objects during the operation. The skip round shield also received damage as the shield fabric was torn from the metal.

DISPOSITION:

Sauk County ERT members assisted in the city of Kenosha.

I was assigned to be in command the Field Force half of our team. Officers staged at the HS until we were deployed to the Courthouse. Sauk Field Force members were deployed to the intersection of 10th Ave and 57th Street. We did stand at the intersection to prevent protesters from coming back onto the park grounds, where they had already been cleared from. [REDACTED] We did hold our intersection and were called back to staging.

SYNOPSIS:

This report is in regards to the Civil Disturbance Unit (CDU) assisting with protests in the City of Kenosha. CDU was deployed to the Kenosha County Courthouse to assist with securing the perimeter of the courthouse complex from the large crowds of protesters. Deputy Robokowski and Officer Jacobs from the Delafield Police Department did deploy less lethal munitions at individuals within the crowd. Reference Deputy Robokowski's supplement and use of force report for further information. Go Pro camera video was taken at the event and downloaded by Lieutenant Ollinger. The detective Bureau needs no follow up.

MAIN:

On Tuesday, August 25, 2020 at approximately 1600 hrs. while assigned as Team Leader for our CDU call out, we were to report to Kenosha Bradford High School for staging. Upon arriving at the High School, we were deployed to the Kenosha County Courthouse to assist with securing the perimeter of the courthouse from the large crowd of protesters. Upon arriving at the courthouse our unit was divided up into three four-man teams that were to rotated conducting perimeter checks within the fenced perimeter of the courthouse. This assignment started at approximately 2010hrs. As the first unit was conducting the perimeter, check of the complex the large crowd of protesters began to push on the security fence in front of the courthouse.

Our CDU unit was then deployed at approximately 2020 hrs. in a line formation in front of the courthouse along with National Guard members and Marathon County Deputies. Due to the aggressive nature of the crowd and their non-compliance with staying away and off the fence along with throwing objects and fireworks at officers less lethal munitions were deployed at the agitators in the crowd. This effort was met with mixed results. I also deployed the HyperSpike sound machine in order to get the crowd to disperse. This was also met with mixed results.

Due to the agitation of the crowd, two bearcat vehicles were dispatched to the scene and assisted in backing the crowd up. Once the bearcats were on scene the CDU unit then formed a line in the park in front of the fence and began to move the crowd back and out of the park. During this time, all of the members of the CDU unit did having objects thrown at them from the agitated crowd of protesters. We continued to move the line forward and were able to back the protesters out of the park. At that point, we stood at a perimeter position until National Guard members relieved us. This ended our involvement for the remainder of the event.

GO PRO CAMERAS:

Deputy Kibler, Deputy Jacobi, and Deputy Maylen wore Go Pro cameras. Lieutenant Ollinger downloaded these videos.

CONCLUSION:

This report is for record purposes only. Reference Deputy Robokowski's supplemental report and use of force report regarding the deployment of less lethal munitions during the event. The detective Bureau needs no follow up.

INVOLVEMENT:

On Tuesday 8/25/2020, I was assigned to the Civil Disturbance Unit of the Waukesha County Sheriff Department in full department uniform. The unit was tasked with providing security to the Kenosha County Courthouse. I was issued a SL6/40mm launcher as a trained grenadier.

I personally observed the Deputies, Police Officers, and National Guardsmen in front of the courthouse having bottles, explosive devices, and other projectiles thrown at them by protesters from my elevated position on the second floor inside the courthouse. I also verbally witnessed the assembly be declared illegal, and multiple lawful legal orders for protestors to disperse and cease hostile behavior towards Law Enforcement.

I launched a total of six 40mm foam baton rounds at protesters who actively continued to engage in threatening behavior toward law enforcement officers to include launching projectiles. I discharged the 40mm baton rounds from the second floor of the Courthouse, as well as from the park, and courtyard directly in front of the Courthouse throughout the evening.

Officer Ryan Jacobs was also assigned as a grenadier refer to his report for details regarding his involvement and use of force.

I completed a use of force form documenting my deployment of 40mm foam baton rounds. I used no other munitions that evening. This ends my involvement in this matter.

There was much civil unrest that evening in the city of Kenosha, however deployment of munitions or any other action other than mere presence was not required of us. Our involvement was;

8:00 PM - Staged at intersection of 39th AVE and Washington St for report of multiple 100's of vehicles coming to staging.

12:00 AM - Deliver supplies to 56th St and Sheridan

12:15 AM - Respond to intersection of 60th St and Sheridan for observations.

12:45 AM - Staged at 52nd ST and 14th AVE

2:30 AM - Responded back to staging (Bradford High School)

At approximately 4:00 AM we were back at our office for the end of our tour. Again, no munitions or any other use of force was used by our SWAT team.

Lt. Urquhart,

Regarding assistance from the Ozaukee County Metro Special Response Team (SRT) on Tuesday, 08-25-20, the following rounds were deployed during the civil unrest in front of the courthouse building/Civic Center Park:

9:55pm – 1 cannister of CS riot control continuous discharge gas deployed from MRAP. This cannister was picked up by a rioter and thrown back at the MRAP striking the driver's side windshield.

10:00pm – 1 cannister of CS riot control continuous discharge gas successfully deployed from MRAP.

10:07pm – 1 cannister of CS riot control continuous discharge gas successfully deployed from MRAP.

10:08pm – Team members observed several rioters throwing dangerous projectiles at the crowd control teams. The rioters were shielding their bodies behind a piece of standard size plywood. The subjects were actively throwing bricks which were striking the crowd control team. One of the subjects momentarily left the barricade and later returned to the barricade with a backpack. From the angle of the MRAP team member Mueller could still see bricks being thrown at the crowd control team by the subject hiding behind the barricade. When not actively throwing bricks the subject's right buttocks, thigh, and calf were facing upward and exposed. At approximately Team member Mueller deployed three less-lethal drag stabilized bean bag rounds from the MRAP turret. The first round hit the ground to the left of the subject. The second and third rounds hit the subject in the thigh/buttocks area. The subject then stood up and fled the area without being apprehended or identified.

No other canisters of gas or less lethal rounds were deployed during the remainder of the night.

SWAT ASSIGNMENT

WAPD SWAT was initially deployed to stage on 10th Ave just north of 56th St. in support of the crowd control Officers within the fenced in area, however the MRAP was unable to enter the fenced in area due to the gate placement on 54th St. WAPD SWAT was then reassigned to stage at the Kenosha Sports Complex at 39th Ave & 42 St.

After staging at the Kenosha Sports Complex for a short while, WAPD SWAT was requested to move to 56th St. & Sheridan Rd. to assist with crowd control.

SWAT DEPLOYMENT AND ON SCENE OBSERVATIONS

Upon arrival to the intersection of 56th St. & Sheridan Rd. WAPD SWAT observed hundreds of protestors in the Civic Center Park and Sheridan Rd. These protestors were starting fires and actively throwing rocks, bottles, fireworks, unknown liquids and other objects at the armored vehicles, the fencing around the court house area and crowd control Officers who were on foot. The protestors were

repeatedly told to leave the area as it was deemed an Unlawful Assembly however they refused.

At one point a large contingency of crowd control Officers and several armored vehicles moved the protestors out of the Civic Center Park and onto Sheridan Rd.

Once on Sheridan Rd., the protestors again refused to leave the area and/or leave the roadway and continued to start fires and throw items at the Police. The protestors were also utilizing plywood, signs, umbrellas, etc. to block 40mm less lethal deployments. Additionally unlawful assembly announcements were continuing to be made via armored vehicle PA systems.

While on Sheridan Rd., WAPD SWAT was paired with several other armored vehicles in addition to the large contingency of crowd control Officers. At the request of tactical command, the armored vehicles and crowd control Officers would direct the protestors south and hold or move the protestors south and back away north.

Tactical command requested several times for this process to occur which led to the protestors being directed as far south as 60th St. & Sheridan. While doing so the protestors continued to throw items at the police, created barricades in the roadway with signs/dumpsters/construction trailers, and lit multiple fires. Also observed within the crowd were at least 10-15 males open carrying rifles.

NARRATIVE**PRELIMINARY INFORMATION**

I responded with WAPD SWAT to assist with this incident. I was assigned the hatch of the WAPD Rescue Vehicle with a 40mm projectile launcher. SGT Corwin was assigned to pass me munitions as I requested them. I had my WAPD issued Axon body camera on my body armor and activated.

IMPACT MUNITION USE

WAPD SWAT was sent to assist with crowd control after it was declared an unlawful assembly. The Rescue Vehicle arrived on scene and parked on W. Sheridan Ave., near the Court House. We were assisting Mobile Field Force officers who were on foot. I was in the hatch of the Rescue Vehicle with a 40mm launcher to use the impact munitions on people throwing rocks, bricks, bottles, unknown liquids and other items that could injure the officers and citizens in the area.

During the entire time I was in the hatch, people threw, and continued to throw, objects and fireworks, and launch fireworks at the Rescue Vehicles and officers in the area. All of the below munitions were fired at the people to stop them from throwing the objects and fireworks at the police and to protect any citizens in the area who might have been hit by the objects.

At about 2135 hrs., I saw a black male wearing dark clothes in front of the Rescue Vehicle throwing hard objects at the Rescue Vehicle. At I fired a 40mm less lethal foam impact munition at his upper legs. The foam impact munition appeared to hit him as he jumped back and fled.

At about 2138 hrs., I saw a male black wearing red shoes was using a garbage truck for cover. He would come out, throw a rock or brick and return to cover. He came out with an object in his hand after throwing several, threat it, and I fired a 40mm foam impact munition at his legs. The foam impact munition hit is legs and he fled between the trucks. SGT Corwin confirmed the male threw a brick at the Rescue Vehicle.

SGT Corwin informed me there was someone using a green laser at our 10:00 position, relative to the front of the Rescue Vehicle.

At about 2141 hrs., the officers in the Rescue Vehicle called my attention to a black male with black pants with a white stripe in front of the Rescue Vehicle, throwing hard objects at us and the officers in the area. I saw him throw a large piece of concrete at the Rescue Vehicle. It hit the Rescue Vehicle in front of me. I fired a 40mm foam impact OC munition at his legs, hitting his legs.

At about 21:44 hrs., an unknown person threw a bottle filled with an unknown fluid at the Rescue Vehicle. The bottle landed short.

At about 21:46 hrs., I saw bottle rockets coming from behind a fire truck, aimed at police in the area.

At about 2221 hrs., I saw a black male behind a SUV on a side road, using the SUV as cover, throwing bricks/rocks at the Rescue Vehicle. Due to his effective use of cover only his head was exposed until he periodically popped out to throw objects at the officers and Rescue Vehicle. I was unable to fire an impact munition at him due to this use of the cover. One large rock he threw struck a Mobile Field Force officer in the helmet/face shield area. The male ultimately ran behind a building as we advanced.

At about 2227 hrs., as the male, above, moved from behind the SUV, exposing himself, I fired 40mm .60 cal., stinger munition, directly at his legs.

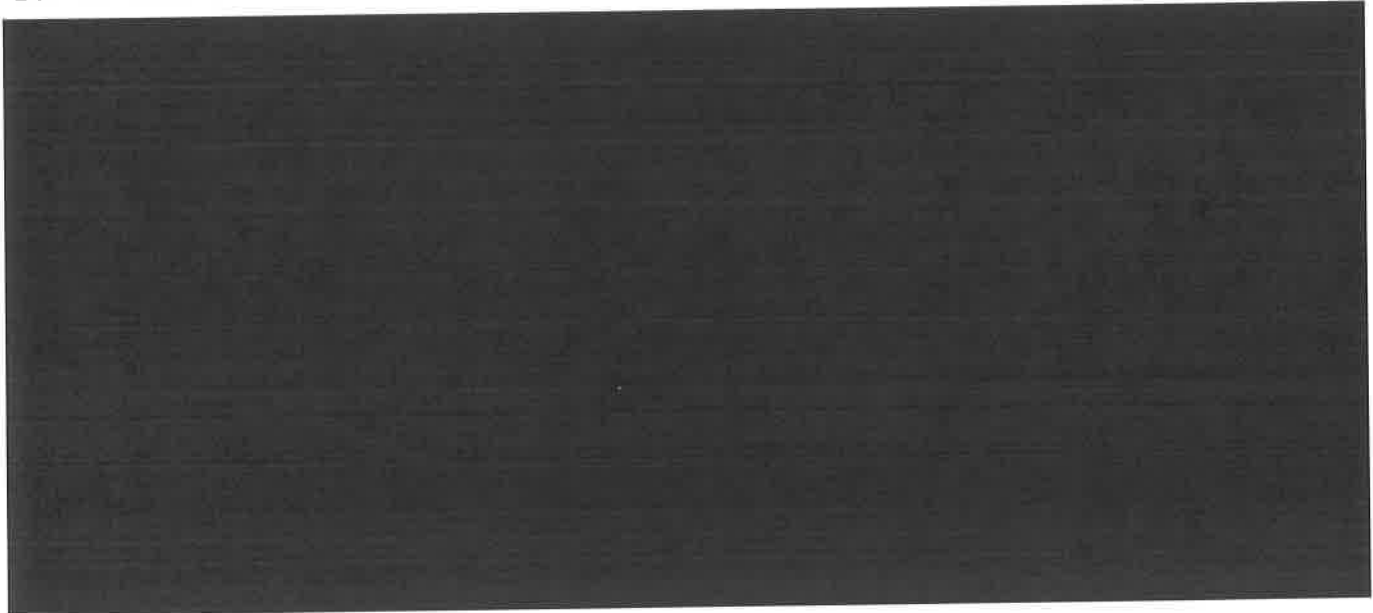

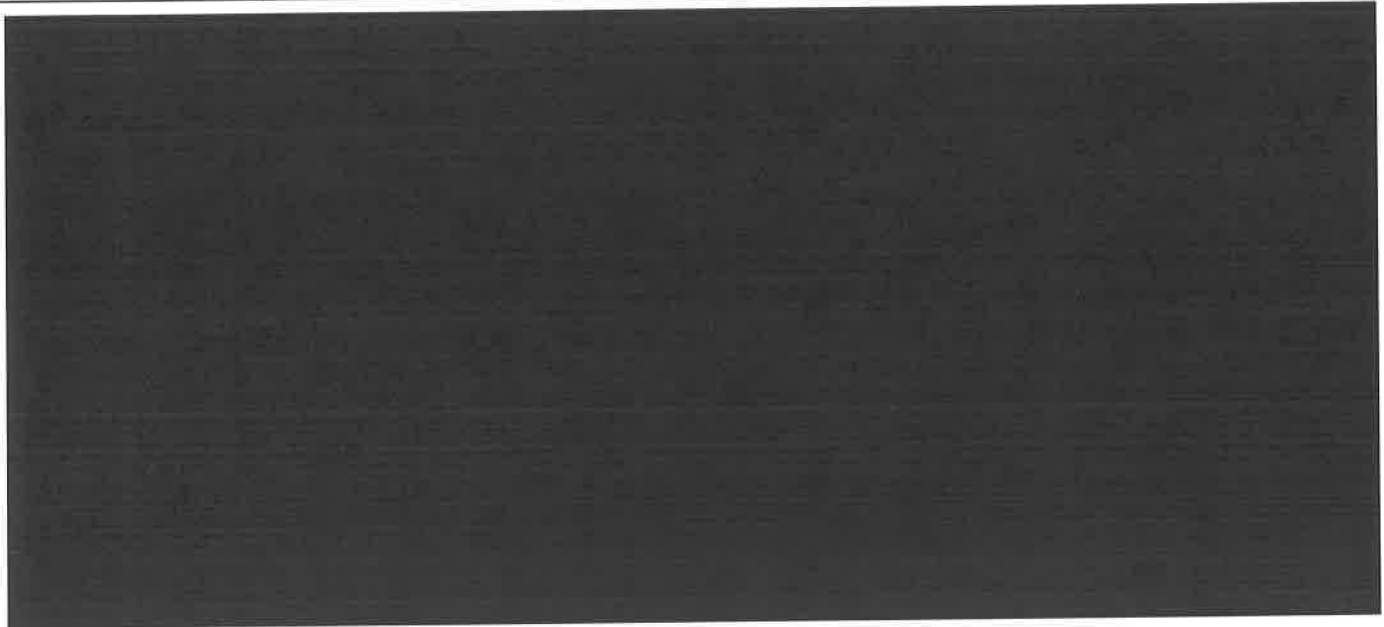

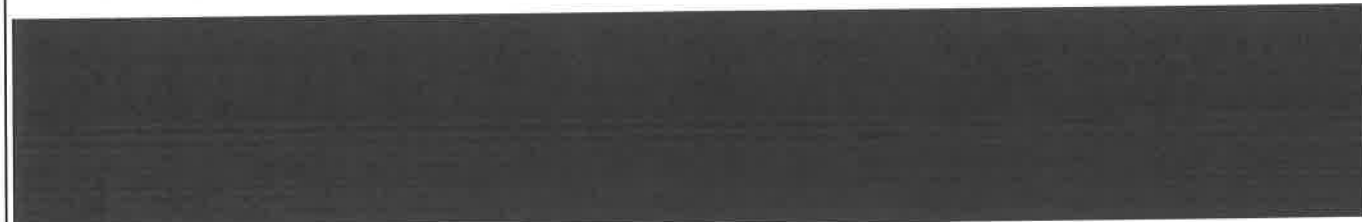
On Tuesday 25 August 2020, I was the tactical commander for the West Allis Police Department SWAT team. Seven (7) West Allis Police Department SWAT operators were deployed to Kenosha to assist with civil unrest. We were mobile throughout the night in our MRAP Police Rescue Vehicle, assisting with crowd control efforts and holding a perimeter in the area of Sheridan Rd. from approximately 54 St. to 60 St. Throughout the night, we observed several individuals armed, mostly with long guns in the area of 60th St. and Sheridan Rd. Our vehicle, as well as other armored police vehicles and crowd control officers on the ground had been subjected to rocks, bricks, bottles, fireworks and unknown fluids being thrown at us. Our team deployed various less-lethal munitions at target specific individuals who were actively engaged in throwing items at officers and vehicles throughout the night.

My body worn camera (BWC) was activated and captured the following activity. The following is based on my memory and review of my BWC. For continuity and exact quotations, please refer to the recording in its entirety.

At approximately 2345hrs., we were positioned on the north side of the intersection of 60th St and Sheridan Rd. Our Police Rescue Vehicle was facing south. Sgt. Corwin was positioned in the hatch and was monitoring crowds on the south side of the intersection. There were numerous people in the following areas:

5900blk. of Sheridan Rd. - both sides of the street
 6000blk. of Sheridan Rd. - in the roadway
 S/E corner of 60th St. and Sheridan Rd. - vast majority of crowd congregated on gas station parking lot

At approximately 23 minutes into my BWC recording footage, Sgt. Corwin indicated something was going on approximately two (2) blocks in front of us (south on Sheridan Rd.). He said individuals were sprinting to the south.

NARRATIVE

On 08/23/20 at approximately 1740 hours I, Detective Scifres #257, was activated as a member of the Kenosha County Sheriff's Department Tactical Response Team (TRT) due to Civil Unrest in the City of Kenosha. I was assigned to a four man Quick Reaction Team due to the growing concern of Civil Unrest after an Officer Involved Shooting.

My team was assigned to respond to the Public Safety Building (PSB), located at 1000-55th Street, to support the Kenosha County Sheriff's Department Crowd Control Team. Approximately 150 to 300 subjects were approaching the front (south side) of the PSB. The subjects were protesting and refused to disperse the parking lot in front of the PSB. The Kenosha County Sheriff's Department Crowd Control Team was holding a line in front of the PSB to protect the PSB. My team was equipped with 40 mm direct impact munitions, 12 gauge drag stabilized impact rounds, and canisters of hand deployed chemical munitions.

While supporting the Kenosha County Sheriff's Department Crowd Control Team from behind the line, I observed multiple objects being thrown from the large hostile crowd. The protesters became extremely agitated and started throwing objects, such as large rocks with sizes varying from baseball to softball size, glass bottles, and filled water bottles with unknown substances to name a few. I observed the glass entrance/exit door at the front of the PSB shattered from objects being violently thrown by the hostile crowd. I observed multiple officers being struck with objects violently thrown from the hostile crowd. I heard a lawful dispersal order given multiple times to the protesters turned rioters by an armored vehicle using the Public Announcement (PA) system. The rioters refused to comply with the dispersal order of an unlawful assembly and chemical munitions were deployed. I observed an adult white male subject wearing blue colored jeans and a white colored short sleeve shirt running towards the hand deployed chemical munition. I was equipped with the 12 gauge less lethal shotgun loaded with drag stabilized rounds. Based on my training and experience, the 12 gauge drag stabilized round is a specialty impact munition used as a dynamic, high energy, single target round for incapacitation or the distraction of a non-compliant, aggressive subject. The 12 gauge drag stabilize round can also be deployed in crowd control situations to protect the riot line, cover or enhance chemical munitions, or target specific agitators of the crowd. When used in this fashion, it is primarily both a psychological deterrent and physiological distraction serving as a pain compliance device to either get the crowd, or subject, moving or keeping them at a designated distance.

The white male subject attempted to retrieve the chemical munition to throw at the Kenosha County Sheriff's Department Crowd Control Officers and my team behind the line. I deployed two 12 gauge drag stabilize rounds at the subject. My point of aim and point of impact were the upper thigh large muscles. I observed both rounds strike the upper thigh area of the subject. The subject complied after being impacted with two rounds and fled the area on foot southeast from the PSB. While supporting Kenosha County Sheriff's Department Crowd Control, Kenosha Police

Department Detective Brechue #570 was on my team. KPD Detective Brechue #570 was struck with a large rock on the left wrist. KPD Detective Brechue #570 was later escorted from Crowd Control support to receive medical attention.

After the violent crowd dispersed the front of the PSB, I observed the majority of the crowd disperse towards Civic Park, directly in front of the Kenosha County Courthouse. Kenosha County Sheriff's Department Crowd Control Team reported multiple subjects throwing rocks, glass bottles, homemade explosives, and attempting to ignite a fire on the Kenosha County Courthouse. My team responded to the front of the Kenosha County Courthouse as a support element for KSD Crowd Control Team. I observed multiple subjects violently throwing glass bottles, large rocks, broken cement, and homemade explosives at the KSD Crowd Control Team. I observed Kenosha City garbage trucks positioned on 10th Avenue and 56th Street, Sheridan Road and 56th Street. I observed both garbage trucks fully engulfed with flames and burning. My team deployed different canisters of chemical munitions and less lethal impact munitions to disperse the violent protesters. Less Lethal impact munitions were deployed to protect the chemical munitions from protesters retrieving the chemical munitions and throwing, kicking, or hitting the chemical munitions at KSD Crowd Control Team and us. The protesters dispersed and multiple businesses were set on fire in the area.

On 08/24/20 during the night time hours, I was assigned a four man quick reaction team. We were assigned to support the KSD Crowd Control Team at the Kenosha County Courthouse. KSD Crowd Control reported being struck with glass bottles, rocks, broken pieces of cement, and homemade explosives. Upon arrival, I observed the KSD Crowd Control Team holding a line in front of the Kenosha County Courthouse on 56th Street, in front of Civic Park. I observed approximately 150 to 300 protesters occupying Civic Park and 56th Street. I observed violent protests throwing the reported objects striking multiple Deputies/Officers. The protest violated the mandatory curfew and was deemed an unlawful assembly. I heard dispersal orders given multiple times over a Public Announcement (PA) speaker. The protesters appeared to ignore the dispersal order given multiple times refusing to disperse the area. The protesters continued to yell and throw objects at Deputies/Officers in front of the Kenosha County Courthouse. My team deployed multiple canisters of hand deployed chemical munitions. I deployed multiple 12 gauge drag stabilized impact munitions to protect munitions, stop crowd agitators, and subjects violently throwing dangerous objects at Deputies/Officers with the potential of causing serious bodily injury. My team also deployed multiple rounds of 40 mm exact impact munitions.

The protesters eventually dispersed the area and my team was assigned to respond to multiple structure fires of businesses on 60th Street. Upon arrival, I observed the Probation/Parole Office fully engulfed with flames, along with a furniture store, located on the south side of 60th Street/11th Avenue fully engulfed with flames. I observed the other businesses in the area had

been damaged with broken windows. I observed a vehicle sales lot with all the vehicles damaged. I observed a crowd of multiple subjects growing larger to approximately 70 to 100. The crowd remained peaceful and the Kenosha Fire Department responded to address the multiple structure fires. No further action was taken.

On 08/25/20, my team was assigned to respond to 60th Street and 10th Avenue reference a vehicle fire. Upon arrival, the area was secured and the Kenosha Fire Department responded to attend to the single vehicle fire. [REDACTED]

the subjects and responded to 10th Avenue/63rd Street. My team assisted setting security in the immediate area. My team supported the Kenosha Police Department Crowd Control Team with setting security. I observed multiple subjects and vehicles occupy the parking lot, located on the southwest corner of STH-32/63rd Street. The crowd of subjects began congregating in the parking lot and throwing objects at my team and KPD Crowd Control Team. I observed chemical munitions deployed in the parking lot to disperse the violent crowd. My team deployed multiple 40 mm exact impact munitions to protect the deployed chemical munitions, impact individual agitators, and individuals violently throwing objects at Officers that would cause serious bodily injury. My team later cleared the area with no further action taken.

Valeri Report

On 08/23/2020, I PO A. Valeri 603 was activated as a Kenosha County Tactical Response Team (TRT) Operator, after an Office Involved Shooting, for crowd control. All actions taken by me on this report were as a KSD TRT Operator. On this day, I was assigned to the KSD Bear Cat. Later in the night, we were positioned near the Kenosha County Courthouse (912 56th St). The Bear Cat was being surrounded by hostile and unruly participants of the riot. Some of these people were armed with firearms. The situation became increasingly dangerous as the participants started to throw projectiles at the Bear Cat. They refused to move out of the way of the Bear Cat. For a safe extraction and crowd dispersal I threw one CS Sting Ball through a port on the driver side of the Bear Cat. Prior to this I was seated by the window behind the rear driver side door, which was struck by a bullet of sharp projectile which caused the window to crack. See KSD CN 2020-333515.

On 08/24/2020 I was assigned to the KSD TRT MRAP. I did not throw or shoot any munitions on this day but did assist with scene guard at a structure fire near 60th St/11th Ave.

On 08/25/2020 I was again assigned to the KSD TRT MRAP. We were positioned at the Kenosha County Courthouse for a very large hostile crowd. Shortly after arrival, the MRAP was being struck by projectiles. Announcements were given to crowd to disperse, for which they did not comply. As the MRAP moved south through Civic Park, I was tasked with less lethal munitions. Do to the incoming projectiles striking our vehicles and the hostile/unruly crowd at Civic Park, I threw 1 CS Han-Ball towards that crowd, causing them to disperse. Using several other armor units, we were able to cause the crowd to disperse out of the park and onto Sheridan Rd. While on Sheridan Rd, our MRAP continued to be struck with projectiles from the crowd on Sheridan Rd. We were in the 5700 block of Sheridan Rd, when a group was pushing a dumpster with unknown contents towards us. We were still being struck by projectiles and the crowd was refusing to disperse from the area after verbal commands. I deployed three more CS Han-Balls towards the crowd that was throwing items at us. I also deployed and fired 5 bean bag rounds using a 12 gauge shotgun, which was colored bright orange and labeled "Less Lethal." My point of aim for the less lethal shotgun was the primary target zone of the lower body. The bean bags were directed towards those that were throwing projectiles at the MRAP.

Other Officer's in the MRAP also deployed less lethal munitions, see their reports for further information.

I did not deploy an other munitions on any other day up to 09/04/2020. Further reports will be completed if I deploy further munitions in the days to come.

NARRATIVE

On 08-25-20 at between the hours of 2200-2359 hours, I, Deputy A. Schmit #293, was acting as an Over Watch on the roof top of the Kenosha County Courthouse. I had been positioned on the roof top since 1600 hours that day and observed the situation in front of the courthouse deteriorate.

Initially the crowd gathered in front of the courthouse had been relatively peaceful only engaging in verbal abuse. At approximately 2100 hours I noted that there was an increase in "agitators" armed with homemade riot shields, umbrellas, gas masks, and helmets in front of the fence positioned in front of the courthouse. At one point a group of these agitators began coordinating in an effort to push the protective fence over. I advised command of the situation and the crowd control unit was deployed in front of the courthouse.

As the situation progressed armored vehicles were deployed in front of the fence to assist in dispersing the crowd and protecting the crowd control unit. I heard the PA systems on multiple vehicles direct the agitators to disperse and that they were partaking in an unlawful assembly. The Kenosha County MRAP was positioned in front of the fence facing the crowd. A small group of agitators moved in front of the MRAP up against the bumper pinning the vehicle in. Sergeant Campbell was the vehicle commander of the MRAP at the time of the incident. I heard Sergeant Campbell request over the radio for assistance in pushing the agitators away from the front of the MRAP. At one point I heard over the radio that the agitators were trying to light the front of the MRAP on fire. Addition armor units attempted to use less then lethal munitions to clear the agitators from the front of the MRAP without effect.

I verbalized to the group in front of the MRAP to back away. The agitators did not comply. I deployed two OC Blast rubber ball grenades from the roof top of the courthouse directly in front and to the driver side of the vehicle. These devices provide a loud bang, a flash of light, and disperse OC gas. Both devices landed on the ground and did not strike any agitators directly. The group of agitators began falling back to Civic Park. The MRAP was able to maneuver out of the area.

Glaum Report

On 08/23/20, I, Officer Eric Glaum, was employed with the Kenosha Police Department when I was activated for TRT due to an officer involved shooting in the City of Kenosha. I responded to JSOC and was assigned to Truck 2. We initially responded to the scene of the shooting, roughly the 4000 block of 28th ave, where we provided extra scene security due to an increasingly disruptive crowd on scene. While escorting the riot team from the scene we were being followed south down 28th Ave by a large group, several hundred individuals, that were throwing objects at our vehicle. During this time we took a large rock through the back window of our truck's cab which shattered the window. We were able to escort the team to their bus and leave the area of 28th Ave.

After leaving 28th Ave we responded to the PSB where large crowds had started to form on the north side of the building. The crowd later left for the south side of the building, but Truck 2 remained on the north side of the building to provide security. A short while later, a group of approximately 50 people began to throw objects at us and were seen damaging numerous KPD squad cars parked around the area. These subjects were throwing large rocks, bottles, and other items towards us. I was carrying a non-lethal 12 gauge shotgun. I shot two rounds at subjects that were specifically throwing objects towards officers. This caused the group to flee the immediate area. Later, we responded to the south side of the PSB where there was a large group of angry protesters with numerous subjects again throwing rocks, bottles, and other items towards officers. In an attempt to keep officers safe, and the crowd at a safe distance, I deployed one throw-able Stingball Grenade and a throw-able CS gas. I also deployed several additional non-lethal 12 gauge beanbag rounds at subjects specifically throwing objects at officers and/or attempting to throw back chemical munitions towards officers. While deploying non-lethal beanbag rounds I was aiming for below subject's waists.

After several hours, the crowd had largely dispersed from the park and were not in numerous parts of the downtown, destroying property and lighting fires. At one point Truck 2 was requested to respond to the 5800 block of Sheridan Rd as a car lot had numerous vehicles set on fire and subjects were blocking the road with miscellaneous items. As we drove south down Sheridan Rd we took a large rock through our rear driver side window, causing it to break. The rest of the evening we assisted by providing security for KFD and officers in the general area.

The following day, 08/24/20, I was again assigned to Truck 2 and we deployed to the south side of the courthouse where a large group of several hundred protesters had amassed and were attempting to set it on fire. Numerous people in the group were again throwing rocks, bottles, fireworks, and various other objects towards officers. I again was again carrying the non-lethal shotgun and deployed roughly 30 beanbag rounds while at this location. I was protecting chemical munitions deployed by other officers from rioters attempting to throw them back and subjects that were throwing the above mentioned items at officers that could cause bodily injury. I targeted the lower extremities of subjects while deploying these rounds. We remained on this location for several hours until we later again assisted KFD at the scene of several fires on 60th St between 10th Ave and 13th Ave.

On 08/25/20, Truck 2 was assigned as rear security for a large group of riot control personnel, starting in the 5500-5600 block of Sheridan Rd. I was carrying the 12 gauge non-lethal shotgun again. As in the previous nights, numerous subjects in the protesting group were throwing large rocks, bottles, fireworks, and other objects towards officers. These objects were easily of the size that they could have caused significant bodily harm to officers. I deployed several non-lethal rounds to protect chemical munitions and towards subjects throwing the above listed items towards officers.

Algiers 23-24-25

On 8-23-20 I, Officer Algiers, was on duty and in full uniform for the Village of Pleasant Prairie, Kenosha County, State of Wisconsin. At approximately 6:05pm I was requested to respond to Bradford High School for a Kenosha County Tactical Response Team (TRT) activation (KSD# 2020-333832). TRT was requested to assist with crowd control at the scene of a shooting at 40th St. and 28th Ave in the City of Kenosha. I responded to our staging area shortly after and was assigned to Team 2, a four-man team in a marked Kenosha County pickup truck.

Team 2 responded to the scene of the shooting at approximately 8:20pm and assisted with crowd control at 41st St. and 28th Ave. There was a crowd of approximately 50 or more people in the area of 41st St. and 28th Ave. While assisting with scene security here there were several unknown subjects that were yelling "fuck 12" and "fuck the police" at us. Racine County Riot Team then arrived on scene and assisted with crowd control at the intersection of 41st St and 28th Ave. At approximately 9:14pm an officer from the Kenosha Police Department at the crime scene was struck in the head with a thrown brick and went unconscious. At approximately 9:30pm we were advised that we could clear from the scene. Our truck followed the Racine County Riot team as they walked southbound on 28th Ave to 45th St to a city transit bus. While escorting the Racine County Riot team to their transit bus the large crowd from the scene was following our fully marked Sheriff pickup truck. The crowd continued to yell profanities at us and began throwing objects at our truck and at the riot team we were escorting. Multiple bricks and rocks struck our truck and broke out the rear window of the truck cab. At approximately 9:40pm the riot control team was able to board the city transit bus and we were able to clear from the scene.

We returned to staging at Bradford High School. We were then assigned to the Public Safety Building (PSB) due to a large crowd gathering outside here. Team 2 responded to the north side of the PSB to provide security for the building and property. Approximately 12 to 20 unknown subjects were in the parking lot at 54th St. and 10th Ave. I observed damage to marked squad cars parked on the 1000 block of 54th St. I also observed a subject standing on top of a marked squad car, jumping on top of the roof, causing extensive damage to the vehicle. Subjects then began throwing rocks, bricks, and bottles at officers. Due to the violent behavior of this crowd and the unprotected property, including gas pumps, the decision was made to deploy chemical munitions to disperse this crowd. I then deployed one canister of Riot CS chemical munitions gas on to the 1000 block of 54th St. The chemical gas was effective in dispersing the crowd and the crowd moved north towards 53rd St. We continued to provide security for the north side of the PSB until additional riot personnel arrived. We were advised via radio that there was a large group of people gathering on the 5500 block of 10th Ave. This group was actively throwing rocks at the Kenosha County Tactical Unit armored vehicle, PSB, and the Courthouse. We were also advised that the group was attempting to light the courthouse on fire. We responded to the 5400 block of 10th Ave. The crowd was advancing northbound on 10th Ave and continuing to throw rocks and other debris at uniformed officers. I then deployed one CS Riot chemical agent on 10th Ave north of 56th St. I also deployed one 40mm Exact Impact munition to an unidentified subject that was attempting to pick up a CS chemical agent gas canister. This round was delivered to the primary impact areas of the subject.

On 8-24-20 I was assigned to Team 2 during the disturbance at Civic Park in Kenosha (KSD# 2020-333833). Team 2 was deployed to the south side of the Kenosha County Courthouse. There was a large crowd of hostile subjects gathering in the park directly south of the courthouse. This crowd was actively throwing rocks, glass bottles, and fireworks at officers protecting the south side of the courthouse.

Several officers and armored vehicles gave verbal command to the group to disperse due to the unlawful assembly. I deployed numerous 40mm exact impact rounds at subjects that were actively throwing dangerous objects at officers. I also deployed 40mm exact impact rounds at subjects attempting to pick up or manipulate CS chemical gas canisters that were deployed in this area. I deployed various 40mm exact impact rounds, including regular range impact munitions, OC exact impact munitions, CS exact impact munitions, and extended range OC impact munitions. I deployed a total of three 40mm 50 meter Warning/Signaling munitions. An officer from the crowd control team on the south east corner of the courthouse was injured and fell to the ground. This line of officers began to collapse due to various objects and fireworks being thrown at them and attempting to protect the injured officer. I deployed an aerial warning/signaling munition, at an upward angle, to the area of 56th St. and Sheridan Rd. to disperse the violent crowd. Two additional aerial warning/signaling munitions were deployed to large group of subjects in Civic Park that were creating a barricaded wall. As they created this wall they were advancing towards crowd control officers in front of the courthouse while also throwing objects at them. These two aerial warning/signaling munitions were deployed in an upward angle in the direction of the subjects in the park.

On 8-25-20 I was assigned to Team 2 again during the disturbance at Civic Park in Kenosha (KSD# 2020-333836). Team 2 was deployed as a mobile field force to the area of 56th St. and Sheridan Rd. Officers and armored vehicles gave verbal warnings to the crowd to disperse but they refused to listen to commands. While at this intersection officers were being struck with large bricks and rocks from subjects on the south east corner of 56th St. and Sheridan Rd. Crowd control teams began to deploy CS chemical agents to disperse the violent crowd. While the chemical agents were in use I deployed several 40mm exact impact munitions at subjects that were attempting to kick and/or pick up the chemical agent canisters. Crowd control officers began moving the violent crowd southbound on Sheridan Rd. from 56th St. This crowd continued to throw fireworks, rocks, glass bottles, and other miscellaneous items at officers. An unknown subject in the crowd threw a yellow blow torch tank containing propane fuels. This tank was turned to the on position and actively dispersing propane gas at officers. I then deployed additional 40mm exact impact rounds at the primary target areas of this crowd.

NARRATIVE

On August 25rd, 2020 at approximately 3:00 PM, the City of Kenosha Police Department requested the assistance of the Kenosha County Tactical Response Team (TRT) with a civil unrest situation stemming from an officer involved shooting which occurred near 40th St. and 28th Ave. in the City of Kenosha. This initial incident occurred under KPD case #2020-46498. The request was made as a continuation of the mutual aid request due to continued civil unrest and rioting which was occurring within the City of Kenosha. Multiple agencies had also responded to assist the Kenosha Police Department.

At approximately 7:00 pm, TRT personnel was forward staged at Bradford High School (3700 Washington Rd.). The following list of vehicles/personnel was utilize:

- KSD Truck #533 - KPD Detective/ATL B. Wilson #533
- KSD Truck #534 - KSD Detective/ATL J. Scifres #534
- KSD MRAP #317 - KPD Sergeant/Operator T. Zukauskas #550
- KSD Bearcat #535 - KSD Detective/TL J. Zarletti #239

TRT members were separated to provide not only assistance to the Kenosha Police Department but also to the multiple agencies that had responded to assist. Mobile field force 1 was set up which included the Bearcat and truck #534. This unit was a combined unit of TRT, Kenosha Police Crowd Control Unit, and Kenosha Police patrol officers. This unit was set up to respond to situations which arose requiring additional assistance that patrol could not safely handle. Truck #533 was implemented in mobile field force 2 to perform similar tasks. The MRAP staged for a period of time in the high school parking lot.

A large violent crowd had again amassed in Civic Park, south of the Kenosha County Courthouse. This crowd was again throwing heavy debris items at law enforcement personnel, damaging buildings, and blocking traffic on Sheridan Rd. and 10th Ave. TRT members from Mobile Field Force 1 (MFF 1) were sent to provide security assistance to KPD officers who were reporting a break in at the Dinosaur Discovery Museum. MFF1 responded and was able to set up security around the building and also conduct a protective sweep of the interior of the building for any persons inside. No persons were located and the building was eventually secured. MFF 1 remained on scene in order to prevent movement of the violent crowd back to the museum.

TRT members in Mobile Field Force 2 (MFF 2) were utilized in the 5800 block of Sheridan Rd. to control crowds in that area. MFF 2 was utilized to disperse the crowd south on Sheridan Rd. and cease the unlawful assembly. The MRAP was also utilized to assist MFF 2 with dispersing the crowd southbound on Sheridan Rd. During this dispersement, TRT members utilized less lethal and chemical munitions to disperse the crowd. The crowd was using bricks, rocks, firework mortars, and other items to assault law enforcement officers on scene. Force was used against those hostile subjects in order to cease their assaultive behavior.

MFF 1 was redirected to a reported fire at The Real C&M Truck Repair (1108 - 60th St.). MFF 1 was advised that tires were reported to be on fire in the lot at that location. MFF 1 was to provide scene security for Kenosha Fire Department personnel to respond to extinguish the fire. MFF 1 responded and was able to secure a portion of 60th St. from 10th Ave. to 13th Ave. MFF 1 stood by until the fire was extinguished.

During the time MFF 1 held the scene, chemical and less lethal munitions were deployed to disperse a crowd that began throwing bricks and rocks at law enforcement personnel on scene. Once that hostile crowd was disbursed, use of chemical and less lethal munitions ceased.

Once hostile crowds had been dispersed, TRT members returned to staging and were eventually cleared at approximately 3:00 am. Reports were completed by TRT members who utilized less lethal and or chemical munitions. Those reports are either attached with this report or completed as supplements under this case number. No further action was taken.
