

As we push forward in our efforts to protect our Nation, OFO Operations will require daily reporting on our activities as related to this Executive Order. Reporting will include encounters in the air, land and sea environments with anyone who arrives into the U.S. from the seven (7) countries (Iran, Iraq, Libya, Somalia, Sudan, Syria and Yemen) that meets the criteria outlined in the Executive Order and the instructions issued to the field by Admissibility and Passenger Programs.

Using the attached spreadsheet, data should be captured daily for the 24-hour time period beginning at 0300 (EST) – and ending at 0259 hours (EST). By 0500 hours (EST) daily, each Field Office is required to submit their data from the previous 24-hours to OFO Field Liaison (b)(6), (b)(7)(C) Reports must be submitting using the attached Microsoft Excel template document. Field Liaison will consolidate these reports into a final report senior CBP and DHS leadership.

Refugees who were en route to the United States on Friday evening have been detained at U.S. airports and restricted from the country as a result of President Trump's executive order banning their entry.

Lawyers for two Iraqi refugees detained at New York's John F. Kennedy International Airport filed a middle-of-the-night lawsuit in federal court challenging Trump's executive order as unconstitutional and seeking the release of their clients.

They also are seeking class certification so they may represent all refugees who are being similarly held at U.S. ports of entry. Immigration advocates say at least one refugee family is detained at San Francisco International Airport, but it is not clear how many refugees are currently detained at airports nationwide.

Trump's executive order suspends admission of all refugees for 120 days and calls for a new system to tighten screening of those seeking entry to the U.S. from predominantly Muslim countries. Trump said that the goal is to screen out "radical Islamic terrorists" and that priority for admission would be given to Christians.

The executive order drew immediate condemnation from advocates for refugees and from the Council on American-Islamic Relations (CAIR), which announced plans to file a lawsuit next week challenging Trump's order as unconstitutional.

"There is no evidence that refugees – the most thoroughly vetted of all people entering our nation – are a threat to national security," Lena F. Masri, CAIR's national litigation director, said in a statement. "This is an order that is based on bigotry, not reality."

Both Iraqi men now detained at JFK had been receiving pro-bono legal assistance for several months from the New York-based International Refugee Assistance Project. Betsy Fisher, the organization's policy director, said the men were in the air on separate flights when Trump signed the temporary ban on refugees Friday. She called their detention "our worst-case scenario."

"In the coming weeks we will be advocating to show why this policy is bad for U.S. national security, why it goes against our humanitarian responsibilities, and why it is fundamentally un-American," Fisher said. "If there is one fundamentally American value then it is welcoming those who are fleeing persecution. At our best, this is what we can do."

One of the Iraqi men detained at JFK, Hameed Khalid Darweesh, 53, had worked as a contractor for the U.S. government in Iraq for about a decade, including as an interpreter for the U.S. Army. He and his wife and three children had spent more than two years trying to secure visas to come to this country.

The Darweesh family landed in New York at approximately 6 p.m. Friday evening, and Hameed Darweesh was detained by U.S. Customs and Border Patrol officials, according to the complaint filed in U.S. District Court for the Eastern District of New York. He has not been allowed to speak with his attorneys and is at risk of being returned to a country where he faces enormous risks to his personal security due to his aid to the U.S. government, the complaint says.

The other detainee is Sameer Abdulkhaleq Alshawi, 33, who was planning to join his wife and young child in Texas. His wife had worked for a U.S. government contractor and came to the U.S. as a refugee in 2014.

Marielena Hincapie, executive director for the National Immigration Law Center, said immigration advocates first learned of immigrants being detained Friday evening after a report from a family detained in San Francisco. The advocates attempted to reach U.S. Customs and Border Patrol but were unsuccessful.

"We were trying to find out if it was lack of communication or what was the plan?" she said in an interview Saturday morning.

Then they learned of the two immigrants from Iraq who had been detained at JFK Airport.

"We don't have any guidance" from U.S. officials, Hincapie said. "That's when we decided to file."

Lawyers for the two Iraqis held in New York have been unable to speak to their clients. When the lawyers asked to speak with them, Customs and Border Patrol agents at JFK said that they were not the ones to field such a request.

"Who is the person to talk to?" the attorneys asked, according to the complaint. The CBP agents responded: "Mr. President. Call Mr. Trump."

Lawyers for the two Iraqis held in New York have been unable to speak to their clients. When the lawyers asked to speak with them, Customs and Border Patrol agents at JFK said that they were not the ones to field such a request.

On January 27, 2017, President Donald Trump issued Executive Order: *Protecting the Nation from Foreign Terrorist Entry into the United States*. It is the policy of the United States to protect its citizens from foreign nationals who intend to commit terrorist attacks in the United States; and to prevent the admission of foreign nationals who intend to exploit United States immigration laws for malevolent purposes.

The attached executive order is effective immediately. Because of the urgency and sensitivity, I ask that each Area PD acknowledge receipt. Thank you.

Detailed guidance is expected within the hour, including reporting requirements. In the interim, this is my summary of tonight's conference call with HQ.

Affected countries: Iran, Iraq, Syria, Libya, Sudan, Somalia, Yemen

Effective immediately, all immigrant (including refugees) and non-immigrant visas of citizens from these countries are revoked. These passengers are to be offered withdrawal of application for admission. If they do not agree to withdrawal, they will be expeditiously removed. If they claim credible fear, they will be processed accordingly. A/G/NATO visa holders are exempt and allowed entry.

LPRs presenting passports from these countries are included in the executive order. However, the Secretary has delegated waiver authority to DFOs to admit LPRs after undergoing a (b)(7)(E)
(b)(7)(E), with proper notation of the DFO waiver in the remarks section. No LPR is to be removed.
Unaccompanied Alien Children, previously admitted refugees, previously admitted asylees, and persons with approved advanced paroles are included in the executive order. These individuals currently require a Secretary approved waiver. HQ guidance will cover the waiver procedures. HQ is requesting DFO delegated authority for these groups as well, but it is not yet approved. Such individuals will also be referred for secondary exam (b)(7)(E), with notation of the approved waiver in the remarks. Until such time that waiver authority is delegated (if at all), we will need to hold the passengers pending Secretary approval of the waiver. These individuals will not be expeditiously removed.
At this time, these procedures are to be followed for the next 90 days. Further guidance will follow at that time.
The State Department has already cancelled all the immigrant and non-immigrant visas, and running rules and creating one-day lookouts. RCLGs are also being involved to offload individuals attempting to board.

NBC News.com - White House Floats 20 Percent Tax on Mexican Imports to Pay for Border Wall

NBC News reports President Donald Trump has not formally proposed a 20 percent tax on Mexican imports to pay for his controversial border wall and is instead considering it among a series of options. White House spokesman Sean Spicer said Thursday. "The goal today is not to be prescriptive. It's to basically say: Hey, here is a way in which the wall can be paid for extremely easy and not say 'this is what we're doing," Spicer told reporters. "This is not what we're rolling out."

CNN.com - Mexican president cancels meeting with Trump

CNN reports Mexican President Enrique Peña Nieto on Thursday canceled a meeting with U.S. President Donald Trump that had been set for next week after renewed tensions erupted over Trump's plan to build a wall on the border. "This morning we have informed the White House that I will not attend the meeting scheduled for next Tuesday with the POTUS," Peña Nieto tweeted.

NATIONAL:

Biometric Update.com - Trump's executive order on immigration addresses biometric entry-exit tracking system

Biometric Update reports President Donald Trump signed an executive order Wednesday which includes a series of initiatives to address immigration, including a proposal to establish a national biometric ID program for non-citizens entering and leaving the U.S., according to a report by Payments Source. According to a draft executive order leaked to civil rights advocates and obtained by The Washington Post, one of the measures of the executive order calls for an "Expedited Completion of Biometric Entry-Exit Tracking System". Section 8 of the executive order draft reads: "The Secretary of DHS shall expedite the completion and implementation of

biometric entry-exit tracking system for all travelers to the U.S., as recommended by the National Commission on Terrorist Attacks upon the U.S."

Federal Soup.com - CBP gets personnel boost in executive order

Federal Soup reports following through on his campaign promise to tackle immigration, Donald Trump has issued an executive order outlining his immigration plan, which includes a boost in personnel for one federal agency. CBP will need to hire 5,000 additional Border Patrol agents as part of the executive order issued on Jan. 25. The order also states that all necessary action must be taken by the CBP commissioner to "ensure that such agents enter on duty and are assigned to duty stations as soon as is practicable."

Washington Post.com - Draft executive order would begin 'extreme vetting' of immigrants and visitors to the U.S.

Washington Post reports the Trump administration plans to start vetting would-be immigrants and visitors to the United States based partly on their opinions and ideology, and will immediately cease the resettlement of Syrian refugees in the United States, according to a draft executive order leaked Wednesday to civil rights advocates and obtained by The Washington Post. The order, if enacted, would signal the beginning of the "extreme vetting" that President Trump promised on the campaign trail, as well as partial implementation of the "Muslim ban," according to civil rights advocates.

USA TODAY.com - Security shortcut Clear expands to more airports

USA TODAY reports thanks to TSA PreCheck, Global Entry and a variety of other programs that pre-vet travelers, 12 million people are now eligible to access the expedited screening lanes at U.S. airports. But even with increased TSA staffing levels and the addition of automated screening lanes at some airports, many trusted travelers still end up waiting in long lines to get their IDs checked by TSA before they can even gain access to the expedited lanes.

LOCAL:

Tucson.com - More drug profits slipping into Mexico as border seizures plummet

Claudia Zuniga Aguilar's daughter needed braces, so she decided to smuggle drug profits into Mexico for a cartel. The Chandler resident was caught with \$9,998 in her purse and wallet as she drove through the Nogales port of entry on March 15, U.S. District Court records show. Zuniga Aguilar, 45, told customs officers she picked up the cash from a man in a Costco parking lot in Mesa. She was supposed to deliver it to an ice cream shop in Sonora in exchange for the down payment on her daughter's orthodontia. The seized money was just below the \$10,000 cash reporting requirement, a tool used by CBPO's to prevent illicit cash smuggling. But as Zuniga Aguilar's case shows, CBP officers also can seize any amount of money if they believe it's the result of illegal activity.

Star Herald.com - U.S. Senator Deb Fischer seeks details on immigration information collection

Star Herald reports U.S. Senator Deb Fischer (R-Neb.) today sent a letter to DHS Secretary John Kelly asking for details about the new administration's plan to collect information on immigrants entering and exiting the country. In the letter, Fischer asks three specific questions regarding the administration's efforts to keep our country safe by establishing a comprehensive biometric entry-exit system.

DVIDShub.net - Trusted Traveler Program

DVIDS reports as of Dec. 1, 2016, Holloman Air Force Base, N.M. adjusted its security policies by adopting the Trusted Traveler Program. "This program was put in place in order to alleviate traffic congestion at the main gate which was a potential vulnerability and safety concern," said Capt. Joseph Lindquist, the 49th Security Forces Squadron commander. "A primary benefit of the program is that it decreases the amount of time it takes for personnel to enter the installation"
