Rather, we are subscribing to receive data generated by OED customers, processed by the vendor (ID.me) who will send the result of such processing to OED. Consequently, we will own the data provided to us by ID.me. This is one of the reasons DAS has precluded the completion of a "cloud workbook".

It is a subtle understanding, but there are myriad understandings when a "cloud" product is mentioned or considered.

- ID.me will charge Agency for detected Socially Engineered fraud, to include individuals who verify through job, romance, financial or other schemes, as those individuals do indeed exist.

Additionally, our legal team does request to exclude 9.1.5 and 9.2 (see attached). I know we're trying to get this in place ASAP and I do apologize on the delays on our side.
