I took SHI off the thread because I did want to let you know that ID.me was one of the companies awarded the \$1.2B BPA from DOL. Therefore, the state would be able to purchase us directly through that contract, off of GSA with DOL. The DOL is holding a webinar this Friday, Sept 17, with more information on the specifics for ordering, etc.

Hopefully that helps! There are significant funds under the BPA for additional items (more help support, training, in-person solutions, etc), so I do think it would be a valuable resource for OED. Happy to provide more info if this is the first you're hearing about it, as well.
