(Supplements Administrative Order S-2009-098)**

**RESIDENTIAL FORECLOSURE PROCEDURES**

The Florida Legislature has authorized and designated funds for the purpose of processing the backlog of residential mortgage foreclosure cases. It is necessary to establish and implement appropriate procedures in order to effectuate this legislative purpose. Accordingly, two sections within the General Civil Division of the Circuit Court and procedures relating to the processing of residential foreclosure cases are hereby established.

By the power vested in the chief judge under Florida Rule of Judicial Administration 2.215(b)(2), it is therefore ORDERED:

1. General Civil Division Sections

All existing and newly filed residential foreclosure cases (“RF”) will be assigned to one of two newly created General Civil Division Sections as follows:

Section I – cases filed in General Civil Divisions A, B, C, D, & F  
Section II – cases filed in General Civil Divisions G, H, I, J & K

2. Case Filings

Any existing or newly filed residential mortgage foreclosure pleadings, motions and other papers will be designated as assigned to Section I or Section II in accordance with section 1 of this administrative order. All motions should be submitted to the appropriate Section I or Section II judge.

3. Case Identification

Attorneys must indicate the appropriate Section on all papers and pleadings filed with the clerk by designating the Section and “RF” beneath the case number and division as set forth in the example below:

RF – SECTION [I] or [II]

4. Calendaring

Attorneys must schedule all hearings in Section I and Section II through the Judicial Automated Workflow System (JAWS). A copy of any motion scheduled and the notice of hearing must be uploaded at the time the hearing is scheduled. Unrepresented parties may schedule hearings by contacting the senior secretary in the respective Section.

5. Telephonic Hearings

For any telephonic hearings, all parties must be conferenced in prior to the call being placed to the court.

6. Foreclosure Packets

All foreclosure packets must be received at least five (5) business days prior to the scheduled hearing. All packets must include the original proposed final judgment along with sufficient copies of the final judgment, certificate of sale, certificate of disbursement, certificate of title, and three (3) sets of stamped addressed envelopes.

7. Sale Dates

Judicial sales will be held daily (excluding weekends and holidays) at 10:00 a.m. and 2:00 p.m. by the clerk.

8. Cancellation of Judicial Sale

The deadline for cancellation of a judicial sale and for the payment of the clerk's sale fee is the day of the scheduled sale, no later than 9:30 a.m. for any 10:00 a.m. sale, and no later than 1:30 p.m. for any 2:00 p.m. sale. The clerk will cancel any scheduled foreclosure sale upon receipt, no later than these deadlines, of a Notice of Cancellation of Foreclosure Sale submitted by plaintiff's counsel. The clerk will accept a facsimile of the Notice of Cancellation of Foreclosure Sale at the number designated on the clerk's website at [www.hillsclerk.com](http://www.hillsclerk.com) (Foreclosure Sales) and the Thirteenth Judicial Circuit website at [www.fljud13.org](http://www.fljud13.org) (General Civil Division). The original Notice of Cancellation of Foreclosure Sale must be filed with the clerk. The uniform Notice of Cancellation of Foreclosure Sale form may be found at [www.fljud13.org/formspage.asp](http://www.fljud13.org/formspage.asp).

9. Additional Procedures

Any additional procedures for residential foreclosure cases will be located at <http://www.fljud13.org/divisionspage.asp> (*Residential Foreclosure Procedures for General Civil Division Sections I & II*).

10. Previous Administrative Order Supplemented

The procedures implemented by this administrative order supplement the procedures of Administrative Order S-2009-098 (*Foreclosure Procedures*), which remain in full force and effect.

11. Effective Date

This administrative order is effective July 1, 2010. All hearings currently scheduled for July 2010 will be heard by the appropriate Section I or Section II judge at the time and date designated in the Notice of Hearing. Beginning August 2, 2010, all hearings will be scheduled and heard as described in this administrative order.

***REAL PROPERTY/MORTGAGE FORECLOSURE BACKLOG  
PROCESSING & ONE-TIME APPROPRIATION***

**Effective July 1, 2010**

**INTRODUCTION**

The Florida Legislature authorized a one-time amount of \$9.6 million (disbursed \$6.0 million to the courts and \$3.6 million to the clerks) to be dedicated to the elimination of the backlog of real property/mortgage foreclosure cases.

The Trial Court Budget Commission has set a target to “dispose 62% of all backlogged Real Property/Mortgage Foreclosure cases (non-disposed and reopened) in FY 2010-11. Due to the setting of this target, it is critical that the term “disposition” be well defined and universally understood. Under the SRS guidelines, a real property/mortgage foreclosure case is disposed of at the time a final judgment of foreclosure is entered by the judge. While the entering of the judgment effectively concludes the judicial interaction on the case, the majority of the Clerk’s work is only beginning.

Clerk time involved in conducting the post sale process alone can be as much as 2.0 hours per case (conforming copies/ mailing/ docketing in system the final judgment; preparing/ mailing/ docketing in system Notice of Sale; conducting sale; answering queries from plaintiffs, mortgagors, 3rd party bidders; issuing/ mailing/ docketing in system certificate of sale; receipting/ reconciling deposits/ final payments of parties and 3rd parties; processing objections to sale filed; issuing/ mailing/ docketing in system certificate of title; and issuing/ mailing/ docketing in system writ of possession).

It is recognized that there is a time lag between the entry of a foreclosure judgment and the time the court provides to conduct the sale of 30/60/90/120 and even up to 150 to 180 days. In addition, 20 to 40% of foreclosure sales are cancelled and subsequently reset. While the court’s time involved in the resetting process is de minimus, the clerk time is as long as the original setting of the sale.

As such, the SRS definition of “disposition” cannot apply as the Clerk’s obligation to conduct the sale and ultimately issue the certificate of title/writ of possession has yet to be completed. Therefore, a more accurate definition of “disposition” for Clerks of the Circuit Court has been defined as follows:

- The processing of all facets of real property/mortgage foreclosure cases through the issuance of the certificate of title/writ of possession or dismissal.

The following reporting system and related business rules are to be used to track the processing of all real property/mortgage foreclosure backlog cases as defined below.

## CLERK OF THE CIRCUIT COURT BUSINESS RULES

### A. GENERAL DEFINITIONS:

- a. ***Estimated Real Property/Mortgage Foreclosure Backlog:*** All real property/mortgage foreclosure cases (non-disposed and re-opened) as of June 30, 2010 as provided by each Clerk to the Office of the State Courts Administrator (OSCA) **AND** estimated FY 10-11 cases as identified by the OSCA in Attachment "A" column "2010-11<sup>2</sup> **AND** all real property/mortgage foreclosure cases initiated prior to July 1, 2010 for which a judgment was issued by the court but a certificate of title/writ of possession was not issued by the Clerk as of June 30, 2010 ("backlog").

**EXAMPLE:** If the Leon County Clerk submitted to OSCA 1,500 non-disposed and reopened real property/mortgage foreclosure cases as of June 30, 2010, **AND** you would then add the FY 10/11 projected cases from "Attachment A" provided by OSCA of 189 for a total of 1,689 (1,500 + 189). Secondly, there were 2,000 additional cases in which a judgment was issued by the court but a certificate of title/writ of possession was not issued by the Clerk as of June 30, 2010. The total would add to the final backlog of 3,689 (1,689 + 2,000).

- b. ***Disposition:*** The processing of all facets of real property/mortgage foreclosure cases through the issuance of the certificate of title or dismissal.

### B. MONTHLY FORECLOSURE EXPENDITURE AND CASE DISPOSITION REPORT:

In order to build a solid baseline for tracking the special one-time appropriation for the disposition of real property/mortgage foreclosure backlog cases as defined above, the attached report shall be filled out by each clerk's office.

This report will track the budgeted appropriation amount, the actual expenditure amount; as well as the disposition of backlog cases for each clerk's office on a monthly basis.

a. Expenditures:

The amount of actual expenditure from the allocation received from the CCOC shall reflect only the direct cost for finalizing the sale of backlog cases. For example, if the Leon County Clerk receives \$32,976.26 for SFY 10/11 (distributed monthly from the CCOC at approximately \$2,748 per month) the total amount that can be reported on the form per month is \$2,748. As such, the annual expended amount would be no more than \$32,976.26.

The expenditure shall not include any administrative overhead costs within the Clerk's organization and shall be utilized for enhanced foreclosure workload efforts i.e.: employees, temporary staff, employee overtime, or other efforts for the purposes of reducing backlog cases. Counties with large caseloads may consider identifying FTE's dedicated to processing only backlog cases and establish a separate cost center. Counties with smaller cases loads may consider a method for reporting revenue and expenditures to a special object code.

b. Dispositions:

The report will include the identification of the estimated number of backlog cases for the Clerk of the Circuit Court and the total cases dismissed and certificates of title issued each month.

Additionally, the report will track the number of sales scheduled and cancelled each month. All cases scheduled for sale during the month regardless of whether the sale occurs or is cancelled should be included (approximately 30% of scheduled sales are cancelled and subsequently reset for sale requiring duplication of sale preparation work by Clerks). Those cases for which the sale actually occurs and the certificate of title/writ of possession is issued should also be accounted for in the "Certificates of Title Issued" section above.

The Court has set a goal of reducing the backlog of real property/mortgage foreclosure cases by 62%. It is recognized that Clerk's time needed to process all facets of the case is significantly higher resulting in lag time to schedule and finalize the issuance of a certificate of title. Based on established criteria and time required for processing the disposition of a backlog case, the Clerks should not be expected to have the same percentage goal as the Court.

Chief Judges and Trial Court Administrators – As mentioned at the JAC meeting in Marco Island, the OSCA plans to provide you with monthly feedback on your progress in achieving the 62% backlog reduction goal. As a reminder, I have attached the target backlog reduction statistics for the foreclosure and economic recovery initiative. We have received a number of inquiries from judges requesting these statistics. You may want to forward the attachment to those judges who are directly working on the initiative.

We plan to send you the following two reports monthly so that you can monitor the statistics that we get in Tallahassee:

- 1) As data comes in from the clerks of court on their SRS reports of filings and dispositions, we will provide you with your circuit's progress in reducing the backlog by 62%. We will send the first report out to you on August 30<sup>th</sup> and then monthly from then on.
- 2) As data comes in from court administration on the status of the cases from the tracking system, we will provide you with analysis of the status and age of cases currently being handled as part of the initiative. We will send the first report out to you on September 30<sup>th</sup>, and then monthly from then on.

These monthly statistics will be provided to you only for internal use and will not be released externally without prior approval. Please let me know if you have any questions. Thanks. Kris

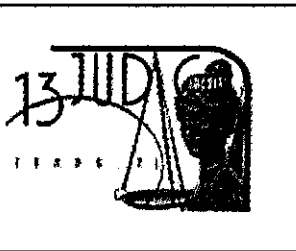

## **ACLU: Keep foreclosure hearings open in Florida courts**

The American Civil Liberties Union is urging judges to ensure that foreclosure proceedings in Florida's courts are open to the public and the media. In letters sent to Chief Justice Charles Canady of the Florida Supreme Court and Chief Judge Donald Moran of Florida's Fourth Judicial Circuit, the ACLU cites a "troubling pattern of foreclosure courts operating behind closed doors." The ACLU says court observers who called two courts to ask about rules governing foreclosure proceedings were told they were closed to the public. Also, the ACLU says an attorney (a reference to April Charney, an attorney with Jacksonville Area Legal Aid) reportedly was "castigated" by a judge for attending a proceeding with *Rolling Stone* magazine reporter Matt Taibbi. His story, critical of the Jacksonville's "rocket docket" court for expediting home foreclosures, hit the newsstands Friday. Florida Chief Justice Canady told the AP on Monday that he is "deeply concerned" about the allegations.

**ADMINISTRATIVE ORDER S-2010-052  
(Supplements Administrative Order S-2009-098)**

**RESIDENTIAL FORECLOSURE PROCEDURES**

The Florida Legislature has authorized and designated funds for the purpose of processing the backlog of residential mortgage foreclosure cases. It is necessary to establish and implement appropriate procedures in order to effectuate this legislative purpose. Accordingly, two sections within the General Civil Division of the Circuit Court and procedures relating to the processing of residential foreclosure cases are hereby established.

By the power vested in the chief judge under Florida Rule of Judicial Administration 2.215(b)(2), it is therefore ORDERED:

1. General Civil Division Sections

All existing and newly filed residential foreclosure cases ("RF") will be assigned to one of two newly created General Civil Division Sections as follows:

Section I – cases filed in General Civil Divisions A, B, C, D, & F  
Section II – cases filed in General Civil Divisions G, H, I, J & K

2. Case Filings

Any existing or newly filed residential mortgage foreclosure pleadings, motions and other papers will be designated as assigned to Section I or Section II in accordance with section 1 of this administrative order. All motions should be submitted to the appropriate Section I or Section II judge.

3. Case Identification

Attorneys must indicate the appropriate Section on all papers and pleadings filed with the clerk by designating the Section and "RF" beneath the case number and division as set forth in the example below:

RF – SECTION [I] or [II]

4. Calendaring

Attorneys must schedule all hearings in Section I and Section II through the Judicial Automated Workflow System ("JAWS"). JAWS may be accessed at the following link: <http://www.fljud13.org/JAWSpage.htm>. A copy of any motion scheduled and the notice of hearing must be uploaded at the time the hearing is scheduled. Unrepresented parties may schedule hearings by telephoning the appropriate senior secretary in Section I at (813) 272-8572 or Section II at (813) 272-5121.

5. Telephonic Hearings

For any telephonic hearings, all parties must be conferenced in prior to the call being placed to the court.

6. Foreclosure Packets

All foreclosure packets must be received at least five (5) business days prior to the scheduled hearing. All packets must include the original proposed final judgment along with sufficient copies of the final judgment, certificate of sale, certificate of disbursement, certificate of title, and three (3) sets of stamped addressed envelopes.

7. Sale Dates

Judicial sales will be held by the clerk daily (excluding weekends and holidays) at 10:00 a.m. and 2:00 p.m.

8. Cancellation of Judicial Sale

The deadline for cancellation of a judicial sale and for the payment of the clerk's sale fee is the day of the scheduled sale, no later than 9:30 a.m. for any 10:00 a.m. sale, and no later than 1:30 p.m. for any 2:00 p.m. sale. The clerk will cancel any scheduled foreclosure sale upon receipt, no later than these deadlines, of a Notice of Cancellation of Foreclosure Sale submitted by plaintiff's counsel. The clerk will accept a facsimile of the Notice of Cancellation of Foreclosure Sale at the number designated on the clerk's website at [www.hillsclerk.com](http://www.hillsclerk.com) (Foreclosure Sales) and the Thirteenth Judicial Circuit website at [www.fljud13.org](http://www.fljud13.org) (General Civil Division). The original Notice of Cancellation of Foreclosure Sale must be filed with the clerk. The uniform Notice of Cancellation of Foreclosure Sale form may be found at [www.fljud13.org/formspage.asp](http://www.fljud13.org/formspage.asp).

9. Previous Administrative Order Supplemented


The procedures implemented by this administrative order supplement the procedures of Administrative Order S-2009-098 (*Foreclosure Procedures*), which remain in full force and effect.

10. Effective Date

This administrative order is effective July 1, 2010. All hearings currently scheduled for July 2010 will be heard by the appropriate Section I or Section II judge at

the time and date designated in the Notice of Hearing. Beginning August 2, 2010, all hearings will be scheduled and heard as described in this administrative order.

The legal terms Stay(ed) and Abate(d) have very specific and different meanings in the law. My suggestion would be that in most foreclosure actions the basis for not proceeding to disposition is due to a "Stay of the proceedings". As such, I would suggest the following tracking categories.

- ~~Case Stayed or Abated~~ – Bankruptcy
- ~~Case Stayed or Abated~~ - Pending resolution of another case
- ~~Case Stayed or Abated~~ – by Agreement ~~by all~~ of the parties
- ~~Case Stayed or Abated~~ - ~~Stay on~~ Appeal pending
- ~~No Action~~ Inactivity or Pending – Attorney inactionivity
- ~~No Action~~ Inactivity or Pending – Insufficient/~~Inaccurate~~ pleadings or documentation
- ~~No Action~~ – ~~Lack of available court resources~~
- ~~No Action~~ Inactivity or Pending – Other (see comments) The reason for non-disposition above can be noted in the Other category, instead of having its own standalone category which may draw attention.

Based upon our discussion today, maybe we can reduce it to something like

The idea is that a case would be placed in one of these status' when the case is in the courts ball field but the court can't take action on a case because of these circumstances. Also, we are looking for a good term to use to reflect the "can't take action" status that doesn't already have a loaded meaning within the courts. For example "inactive" has a specific meaning as does "stayed". I was thinking "No Action" but maybe "Delayed" would be better.

I was planning on having an prototype of the case tracking application ready to send to a few TCA's early next week. I'd appreciate if you would take a look at it. It is difficult to quickly knock off a one size fits all application but it will be very helpful to get some suggestions on how to make it more usable in the field.

Trial Court Administrators,

Thank you for your participation in yesterday's phone call. We appreciate your patience and insight into these projects.

I would like to summarize the issues discussed yesterday concerning the reporting requirements for the Foreclosure and Economic Recovery Case Tracking System (FERCTS) workbooks.

In the interest of keeping the project manageable while still satisfying the essential reporting requirements:

- + The importance of the 62% target numbers have been clarified to better reflect the goals of the initiative and the mission of the courts. The target numbers provide a goal to shoot for but should not be emphasized to the detriment of a fair and meaningful adjudicatory process.
- + In order to reduce the workload impact of the reporting component, circuits do not need to report the dates of reopen or reopened events. If a case that was disposed prior to July 1, 2010 that does not already appear in your application workbook is reopened, this case does not need to be added to the workbook.
- + It is still important that we track the number of cases achieving final disposition. Therefore, new cases that are opened after July 1, 2010 will need to be added to the application as appropriate.

Existing cases achieving final disposition should also be updated and reported.

+ As discussed, several mortgage companies within the state are enacting a voluntary moratorium on their foreclosure proceedings while they review their internal procedures. In many parts of the state, this will affect a significant number of cases currently being processed by initiative staff. While some concrete statistics on the number of cases affected would be useful, the additional workload required to report this circumstance does not justify the result. Active cases affected for more than thirty days by these voluntary stoppages should be reported in the "Inactive – Other" status category in the FERCTS workbook. Initiative staff are encouraged to identify cases affected by a moratorium in the comments field but this is not required.

We are open to suggestions from the circuits as to how we might obtain some hard numbers to help us better understand the impact of these moratoria.

Many jurisdictions report that they have enough cases not affected by the moratoria to keep initiative staff busy.

It is difficult to quickly knock off a one size fits all application but it will be very helpful to get some suggestions on how to make it more usable in the field.

# Judges try to get grip on foreclosure chaos

## Manatee's backlog of cases has judges taking serious actions

MANATEE — The fifth time was the final straw for Manatee County Circuit Court Judge Janette Dunnigan.

Four times in a 2007 foreclosure case, a Fort Lauderdale law firm representing a bank scheduled a hearing and either did not appear or canceled it at the last minute without telling others. So when it happened again April 13, Dunnigan called Smith, Hiatt and Diaz P.A. and issued a warning: Stop it or I'll hold you in contempt of court.

The threat didn't work: The firm subsequently set two more hearings and didn't show for either one. So Dunnigan found the firm in "deliberate, willful and flagrant" contempt after an Aug. 30 hearing and issued a \$49,000 fine, which the firm is contesting.

Legal observers said they believe Dunnigan's act is the first time a Florida judge has sanctioned a so-called 'foreclosure mill' for its practices. But they said it also illustrates a growing effort by judges to regain control of the foreclosure process after years of chaos.

“The system’s overloaded and they’ve got to do something about it,” said Dawn Bates-Buchanan, managing attorney for Gulfcoast Legal Services’ Bradenton office. “The judges all are saying, ‘No more. We’ve had enough.’ ”

That frustration stems from a foreclosure crisis of historic proportions.

Nearly 15,200 foreclosure suits have been filed in Manatee since 2008, according to court records. Mortgage lenders and servicers have initiated foreclosure proceedings against more than 1.33 million Florida homes and repossessed more than 197,300 during that time, according to RealtyTrac, a foreclosure tracking service.

The state courts administrator’s office estimated in March that roughly 500,000 foreclosure cases in Florida were still unresolved. The office said it plans to release an updated estimate later this month.

The legal and financial systems were ill-prepared to handle the crush, resulting in massive court backlogs and delays. It also led to the rise of several law firms that file thousands of foreclosure cases a month, which critics have dubbed “foreclosure mills.”

Local court officials have tried various measures to streamline the foreclosure process, including requiring law firms to file suits electronically; file all relevant documents when scheduling a hearing; designate a primary contact person; and appear in person at all foreclosure-related hearings.

Court officials also set up an automated system for scheduling court hearings and established “rocket dockets” to expedite uncontested cases. But they acknowledge those efforts have had limited success and that problems with incomplete or missing paperwork, missed hearings and non-compliance with court procedures still persist.

“We’ve been bugging these people to do it right and follow the rules for quite a while, but we’re still having issues,” said Chief Judge Lee Haworth, of the 12th Judicial Circuit, which encompasses Manatee, Sarasota and DeSoto counties.

For example, more than one out of every five expedited cases heard during a recent three-week period had some form of paperwork or procedural problem, he said.

That has judges taking a harder stance on those who aren’t following the rules.

On Sept. 17, Sarasota County Circuit Court Judge Harry Rapkin dismissed 61 of 258 cases on his docket because bank attorneys did not follow court procedures. Another 32 cases were continued because of similar but minor issues, Haworth said.

The dismissals mean plaintiffs who want to resurrect their cases will have to re-file and pay filing fees of up to \$1,900 for each case.

But Dunnigan’s contempt order and fine is the strongest rebuke thus far. Besides the missed hearings, she scolded Hiatt, Smith and Diaz for routinely not filing required paperwork.

“The law firm’s lack of consideration for the court’s calendars, their disobedience for this court’s local rules and orders, and their misconduct in handling mortgage foreclosure cases is deliberate, willful and flagrant in nature, and as such is evidence of contempt,” she wrote in her Sept. 2 ruling.

Besides the fine, she ordered the firm to pay \$450 to the homeowner for lost wages and interpreter costs and pay the Barrington Ridge Homeowners Association’s legal costs for the missed hearings. Scott Petersen, the association’s attorney, later said those costs amounted to \$840.

“The abusive practices that the judge attacked have been a serious impediment to the progress of community associations in maintaining financial stability without the benefit of maintenance fees from ‘underwater’ units that have been abandoned by owners,” he said.

Dunnigan also ordered Hiatt, Smith and Diaz to implement a system to assure its attorneys are adequately prepared for and attend scheduled hearings. The firm also was given a Thursday, Sept. 30, deadline to provide signed statements from its lawyers and support staff that they have read the local circuit’s rules of procedure or risk additional fines of \$7,000 a day.

The firm disputed her characterization, saying the missed hearings resulted from the local court circuit's rules not being completely loaded into its database. Partner Roy A. Diaz also said the firm has made "extreme changes" in its internal policies and procedures to avoid more missed hearings.

He filed motions asking Dunnigan to recuse herself from the original case because of "prejudice and bias" and either rescind the order or hold another hearing, which Dunnigan denied Friday.

Consumer advocates and defense attorneys are hailing her contempt order and other actions against such large law firms, including judges in Miami-Dade County, Illinois and New York who wiped out homeowners' mortgages because of misconduct.

Those firms' assembly line tactics also have prompted at least three lenders — Bank of America, Ally Financial/GMAC and JP Morgan Chase — to temporarily suspend foreclosure proceedings in at least 23 states, including Florida.

"Crazy things have been happening and the judges are tired of hearing about it," Bates-Buchanan said. "They're holding plaintiff's counsel to the fire. They're trying to regain control of the process."

Dismissing cases, issuing contempt orders and issuing fines aren't the only tactics that local court officials are using, Haworth said.

They're also spending more time reviewing inactive foreclosure cases. For example, the last filing in a foreclosure suit involving companies owned by U.S. Rep. Vern Buchanan and his brother was on May 19, 2009, records show.

In cases where nothing has been filed in at least 10 months, judges and clerks are telling lawyers to either get the case moving or it will be administratively dismissed.

"Our judges are saying enough's enough," Haworth said. "We've heard every excuse and promise (from bank attorneys) under the sun, and nothing's gotten better. We've had to take stronger measures."

## Sarasota judge simplifies foreclosure cases

### COURTROOM: A checklist of filing errors can bring a case to a halt

Criminal defense attorneys used to call Judge Harry Rapkin "Hang 'Em High Harry" for his tough prison sentences, and his latest crackdown in foreclosure court might have home lenders trying to come up with a similar nickname.

Rapkin unleashed a new order last week, aimed at attorneys for lenders who are still making the kind of simple errors that would be considered ridiculous in any courtroom. A lot is at stake; Rapkin sees hundreds of cases where the lender is minutes away from taking someone's property.

Rapkin's new order completely dismisses foreclosure cases when they do not follow the simplest of rules.

The judge's new order has nine check boxes listing the most common mistakes he sees in foreclosures. The most basic -- not showing up for a hearing -- is listed first. Then there is one for attorneys who filed a motion to win a case that they had previously dismissed, and one for attorneys who filed a motion to win a case they had already won. If one these boxes gets checked, the judge dismisses the case.

The obviousness of the errors is one outcome of the mass volume of foreclosures running through Florida courts and the desire by large legal firms to handle foreclosures en masse, resulting in shoddy practices.

"This isn't brain surgery," said Sarasota attorney Michael Belle, who reviews foreclosure filings for the judges as part of a court-sponsored program.

On Sept. 24, the day Rapkin debuted the order, a quarter of the 250 cases seeking his permission to retake property made one of the errors, 61 in all.

Rapkin's checkboxes give him a quick way to make rulings on the cases. But it also has a twinge of ridicule: as in, can you believe professional attorneys can get things this wrong?

Belle said it is a sad commentary about how a judge feels he must hold the hand of these attorneys just to meet elementary standards.

"Judge Rapkin is now finally saying I can't trust these guys anymore, so here's what I'm going to do," Belle said.

The most direct message gets sent right to the lenders' pocketbooks. The order dismisses the foreclosure, meaning the lender must pay a filing fee up to \$1,900 again if it wants to try to foreclose on the property again.

Attorneys in at least 15 of the 61 cases Rapkin dismissed with the new order have already tried to get a rehearing to try to save their case.

The foreclosure system is still overwhelmed by cases, with attorneys for some lenders each handling thousands of cases.

Foreclosure defense attorneys have decried the paperwork from lenders for years.

Now, problems with paperwork have led some lenders to halt foreclosures in up to 23 states, and the Florida Attorney General's Office is investigating possible fraudulent documents being used to retake homes.

The Trial Court Administrators from each circuit are required to submit a copy of the mortgage foreclosure tracking system workbook to OSCA on the 10<sup>th</sup> of each month following the end of the monthly period. Today is September 10, 2010. Accordingly, please merge Deb Tracy and Elvira Pisacane's copies of the tracking system workbook into one (1) workbook copy. Once the merger is complete, please follow the procedures outlined in the attached and forward same to Mr. Bridenback for final submission.

Lastly, should there be a problem with merging of the copies, please notify me immediately.

### 3. INSTRUCTIONS FOR REPORTING TO OSCA

These instructions establish the reporting standards to be followed when entering and submitting FERCTS information. The FERCTS workbook encapsulates all real property/mortgage foreclosure cases that are non-disposed or reopened (i.e. pending) as of June 30, 2010. The data from this tracking system will be used to provide the Supreme Court with information on the number of dispositions, average age and clearance rate of backlogged real property/mortgage foreclosure cases. Trial court administrators are to submit a copy of the tracking system workbook on a monthly basis to the Office of the State Courts Administrator (OSCA.) OSCA is to receive the copy no more than the 10<sup>th</sup> of the month following the end of the monthly period.

Following are the procedures to use when submitting a copy of the tracking system workbook to the OSCA.

- ✓ This workbook is almost entirely macro driven. Most Microsoft Office installations are installed with a high level of security set by default. To ensure that macros can run for this workbook, there are a few installation steps you must take before you open the workbook. Please see the separate FERCTS Installation Guide for installation instructions.
- ✓ The first transmission of the FERCTS workbook should include updates through July 30, 2010.
- ✓ A copy of the FERCTS workbook must be submitted to the OSCA by the 10<sup>th</sup> of the month following the end of the month being reported. For example, a copy of the workbook updating information through July 30, 2010 is to be sent to the OSCA by August 10, 2010.
- ✓ The workbook copy must be submitted via e-mail to [FERCTS@flcourts.org](mailto:FERCTS@flcourts.org). When submitting, the e-mail, the subject line must contain the following words: "foreclosure and economic recovery" and the date the workbook is submitted for. For example, a workbook submitted on August 9, 2010 for the July 2010 period would contain the subject line "Foreclosure and Economic Recovery Report – 2010/07".
- ✓ The workbook must be submitted in the Excel form provided by the OSCA. To ensure proper operation of the application, the file name is fixed as circuit number, underscore followed by county number and name ending with FERCTS.xls. An example file name is 01\_17Escambia\_FERCTS.XLS.
- ✓ Once the trial court administrators submit a report to OSCA, an error check process will be performed by the OSCA. If reporting errors are identified, the circuit will be notified and errors must be corrected. Corrections will be verified on the next monthly submission.
