It's been a hectic day, but I wanted to touch base with you to make sure I'm proceeding in the right way.

I spoke with the legal assistant for Hickey v. Harbour, Case No.: 502009CA000141A001MR, and she said they will wait until the bank files their motion to set a date.

As for scheduling hearings on 8/26, the problem is that I can't tell from looking at the 94 messages in my inbox how to triage them! We could set a tentative date for one location, but then as I go through the list find out there are more for another place. This is a dilemma. As I mentioned, I have a question for Judge Taylor re: the requirement in the new foreclosure procedures to file an original assignment as part of the foreclosure process. Unfortunately, we do not have original assignments for many of Iberiabank's loans. The reason for this is that since Iberiabank took over the assets of Orion Bank (and a few others in the state) there are quite a few loans to be assigned. The assignments are coming from the FDIC as Receiver for the taken over banks. The assignments are being done in bulk- i.e. 5-10 at a time. The assignments are all recorded in the public records. Accordingly, we only have one "original" assignment covering 5-10 loans. We do have all of the original notes, mortgages and allonges. 




