Here are my thoughts:

In terms of civil backlog across the circuit, we need a full time adjudicator (senior judge or magistrate) to handle foreclosures in SLC alone, and we need senior judge time to handle 10 day+ jury trials in the three coastal counties.

# Regarding SLC foreclosures:

There is perhaps a significant risk that if the defendant has an attorney, the defendant may object to a magistrate in hopes of delaying the case further. However, most of the cases have pro se defendants, and I doubt pro se will be objecting to the magistrates. If Plaintiffs think they can get to the final judgment faster, they will not be objecting to magistrates, unless they perceive the magistrate as being defense oriented. The bulk of the work is handling motion hearings and summary judgment hearings. I question if we will find a senior judge who is willing to handle nothing but foreclosures. Nonetheless, a full time adjudicator handling nothing but foreclosures will make a tremendous dent on that case load. FYI: the Mortgage Foreclosure Task Force noted that Palm Beach County seems to have the best caseload management system in the state due to the fact that they have a full time judge doing nothing but foreclosures.

I am asking the Civil Judges who have family experience chime in on whether you think it is likely magistrates will be objected to in foreclosure cases. When I was in juvi, no one ever objected to the magistrate, but I understand in family it happens with some regularity. So I think those judges who have sat in family have a better sense of the dynamics of objections to magistrates.

Tom, why are we dedicating admin support for Mediation? How is that going to help backlogs?

I am again asking my fellow civil judges to chime in on the issue of whether magistrates would be useful in Martin or Indian River Counties.

3 Admin support, 2 for GM (SR Judge), 1 for Mediation

Expense for GM and SR Judge (If you approve the option below, the amount of expense would increase from 19k to 25k)

We have the opportunity to amend our submission by Friday. Some circuits have raised the issue that both sides have to consent to the magistrate, and that may be a problem... In our circuit, having enough SR judge resources available if we did not use a magistrate may be a problem, however, using only SR judges as adjudicators would simplify matters for us if those resources were available on that level. In essence, our SR judge days to address these backlogged cases would increase from 190 days to 400 days, and increase our expense from about \$19,000 to \$25,000. (Please see the attached spreadsheet.)

In addition I indicated to the OSCA that we would use our resources as follows as a result of a recent request from the OSCA:

We have requested contractual funding equivalent to one magistrate, and funding for 190 SR judge days (approximately 4 days a week for 47.5 weeks equivalent to .73 FTE). Due to the backlog of cases as distributed throughout the circuit the needs are as follows:

St. Lucie County: Magistrate 3 days a week (0.6 FTE), SR judge 3 days a week (0.55 FTE based upon 0.73 FTE total)

The 15<sup>th</sup> Circuit uses a case management system that lists all pending cases by division, links to document images and allows court staff to flag cases with custom flags.

We created "flags" to match the 3 consolidated SRS codes for this project. Case managers flag the cases appropriately. The pending case list is exported into Excel, where we merge it to the OSCA worksheet using Crystal.

This method allows us to also add new (July 1 and thereafter) pending cases to the spreadsheet automatically.

Additionally, we created a flag called "pending in error" to address the hundreds of cases that had been ordered closed, but through human error had not been closed. We exported these into one summary report with case number and case style, and the Clerk closed these much more quickly than the normal case as it was an administrative error.

Trial Court Administrators - On June 4, 2010, the Trial Court Budget Commission (TCBC) discussed the monitoring of the Foreclosure and Economic Recovery Funding Initiative. As reported in an earlier email from me, the TCBC voted at their May meeting that the focus for this project will be on Real Property/Mortgage Foreclosure cases and adopted as the primary goal of the Foreclosure and Economic Recovery Funding Initiative:

❖ 62% of all Real Property/Mortgage Foreclosure cases pending (non-disposed and reopened) will be disposed in FY2010-11

In order to monitor the success of this initiative, the following statistics will be calculated:

- > Clearance rates
- > The number of cases disposed
- > The percent of backlogged cases
- > The average age of target cases

To calculate the above statistics, you will need to track the foreclosure cases throughout the year. As a starting point, you will need information on the cases pending in your circuit at the beginning of this initiative. The following information will need to be requested from the clerks of court:

- 1. Circuit,
- 2. County,
- 3. Uniform Case Number,
- 4. The date the case was initiated,
- 5. The applicable SRS case type of the case
- 6. The date the case was reopened, if applicable
- 7. The date the case was originally disposed (for reopened cases only)
- 8. The SRS disposition category (for reopened cases only)

We met with the FACC yesterday and are planning to send out a letter to all 67 clerks of court asking them to send this data to the OSCA. Please allow us to contact the clerks for this data so that the request can be uniform across the state and the timeframe will be consistent. Once we get the data from the clerks (we are hoping to get it by July 9, 2010), we will format it in a reporting worksheet and send it out to you to track the cases, along with detailed instructions.

One issue that came up during the meeting yesterday was the issue of reopened cases not being reported as closed due to the SRS reporting requirements. We believe that the list of open cases that the clerks will provide may include some cases that are actually closed. Our instructions will request that you review the list to identify those cases that need to be removed due to the fact that they are already closed. Information from the JIS should allow your case manager to determine the status of the cases. Please let us know if the staff person that will be tracking the cases doesn't have access to JIS and we will make sure they get it.

In addition, the OSCA will include in its audit schedule additional time to audit this data to ensure that the data reported is accurate. The Court Statistics and Workload Committee of the Trial Court Performance and Accountability Commission will oversee the data collection instruments and reporting elements.

The distribution of the SR Judge time of 400 days (approximately 1.6 FTE for 47.6 weeks) would be as follows:

Attached are the final versions of the Foreclosure and Economic Recovery Funding Circuit Allocations chart and the In-courtroom Resources chart. As mentioned in my email last Friday, the Trial Court Budget Commission anticipates that the chief judge in each circuit will work with their clerks to ensure the clerks use their separate appropriation (see excerpt of CS/HB 5401 below) to adequately support the court's plan. These plans (clerk's and court's) need to be shared with the Office of the State Courts Administrator so that the Legislature can be informed of the collaborative work on this issue. In addition, the TCBC approved the requirement that the clerks of court provide data support for this initiative. The Clerks of Court Operations Corporation (CCOC) Executive Council met on May 25, 2010 to discuss their Finance and Budget (F&B) Committee's recommendation on the methodology for distribution of their foreclosure Appropriation. They discussed the language in CS/HB 5401 and were aware that the TCBC had asked the chief judges to work with the clerks on the plan.

The CCOC F&B Committee's recommendation distributed the \$3.6 million appropriation in the following manner: Part 1 distributes \$1.8 million based on the number of cases as referenced by the TCBC reimbursed at the average per case rate; and Part 2 distributes the remaining \$1.8 million based on Court determined percentage allocation of court appropriations for foreclosures to each of the Judicial Circuits. Since the CCOC F&B methodology does not allocate by county, there was discussion about an appropriate allocation in multi-county jurisdictions. It was decided that the clerks in multi-county jurisdictions should coordinate with each other, and all clerks, in every circuit, should meet with their chief judges to make sure that the county allocations and the clerks' plans match the plan of the chief judges in each circuit.

The clerks stated their understanding that the funding will be available on July 1<sup>st</sup> and they recognized the urgency to get the resources in place as soon as possible. They discussed the goal of the appropriation to clear the foreclosure backlog and agreed that they would hire resources to assist the courts in achieving that goal. Their chair, Mr. Forman, offered to send a letter any chief judge, if contact was needed. They also passed a motion to develop a simple tracking system to make sure that they were able to track the money spent on this initiative. They plan to present a more formal plan for the tracking system at their next meeting on June 29, 2010.

Please contact the clerks in your circuit as soon as possible about your plan to fund this initiative. Legislative staff have requested that the clerks' and courts' spending plans be submitted at the same time so that they can ensure that the two plans work together in support of the goal.

The Trial Court Budget Commission plans to discuss this matter again at their June 4<sup>th</sup> meeting. Please let me know any update on the status of the communication with your clerks before the meeting, if at all possible. Thank you for your help. Kris

CS/HB 5401 Enrolled - The sum of \$3,600,000 of non-recurring funds from the Clerks of Court Trust Fund is appropriated to the Clerks of Court Operations Corporation to be distributed to the clerks of court where the state court system has distributed the increased resources provided in the 2010-11 General Appropriations Act for workload associated with foreclosure and economic recovery. The corporation shall submit a budget amendment pursuant to chapter 216, Florida Statutes, to distribute the funding among the clerks of court.

I need clarification from Steve and Tom as to whether the senior judges will do all foreclosures or just <u>residential</u> foreclosures.

My understanding is that the case managers and clerical staff will not begin work before July 1. Obviously, they will need some quick training on job

responsibilities and it will take a few days for them to become familiar with the dockets and docket management.

Tom and his staff need to look at what is currently scheduled for July, and plot the dates in July for where the senior judge will be. If something is scheduled and the senior judge will not be there to handle it, the parties will have to be notified that the hearing is canceled an must be rescheduled (and they should call back after July 12, I would suggest, to get a new hearing date).

It will be best for the senior judge schedule for July, Aug and Sept to be posted to the circuit website and procedures posted regarding matters having to be rescheduled.

I know my JA is already getting calls about the transition because the word is out that change is coming (all the circuits are beginning to see this, since this is a state-wide phenomenon). I have told Lynn to advise the attorneys that the Chief Judge and Court Administrator are working out the details of how the new resources are going to be applied to the foreclosure dockets, and as soon as those plans are finalized, something will be posted to the website. I would suggest the other JA's take the same approach.

Similar to the situation already existing in SLC (I do the emergency hearings to stop foreclosure sales and postpone writs of possession since the foreclosure judge is here just a few days each month), I think the same thing will have to happen in Martin and Indian River County (that is, the civil judge will have to do the <u>emergency hearings</u> to stop sales and postpone writs of possession...and only those hearings).

Our reduced allotment is \$212,729, approximately 62.2% of the original \$341,988 contemplated. With this new allotment, we can do as follows:

240 SR Judge days which would be 5 days per week for 48 weeks. I suggest we do 4 days per week at St. Lucie West, and 1 day per week alternating weeks in Indian River and Martin respectively so that each of those counties gets 2 full days per month. This amount of resources should be able to address substantially the foreclosure issues in this circuit for the next year, but for contested trials. #### Good morning,

The Legislature appropriated funding for the Foreclosure and Economic Recovery Program in the amount of \$5,955,606 for FY 2010/11 to the trial courts. These non-recurring funds will be used to provide temporary resources in the trial courts to eliminate backlog in the civil areas. We will be sending information on target backlog reduction goals as well as parameters for implementation and clerk involvement in this program after the May 20, 2010 Trial Court Budget Commission meeting.

The amount of funding authority appropriated for this program is less than the amount originally requested, thus the estimated allotment for each circuit also has been adjusted. You will find the estimated allocation by circuit along with estimated backlog cases in the attached PDF file — Foreclosure and Economic Recovery Program. Considering your adjusted allocation, please indicate, using the attached ForeclosureandEconomicRecovery \_ Distribution spreadsheet, how you would like the funds for your circuit distributed — by category and element. For every element (General Magistrates and/or Senior Judges, Case Managers, General Magistrate/Senior Judge Admin Support and Mediation Admin Support) specify the dollar amount and category in which the funds should be allocated - OPS, contracted services and/or expenses dollars. To allow for maximum flexibility, funds may be expended in one or all of the elements.

As a reminder, the funding methodology developed for this proposal is based on the number of backlogged cases (in the civil areas) in each circuit. A ratio of one General Magistrate, one Case Manager and two Administrative Support positions for every 15,000 backlogged cases was applied to estimate need. One Administrative Support position is dedicated to mediation for the coordination of civil cases covered under this program with the exclusion of residential homestead mortgage foreclosure cases handled through the managed mediation program. I need clarification from Steve and Tom as to whether the senior judges will do <u>all</u> foreclosures or just <u>residential</u> foreclosures.

My understanding is that the case managers and clerical staff will not begin work before July 1. Obviously, they will need some quick training on job responsibilities and it will take a few days for them to become familiar with the dockets and docket management.

Tom and his staff need to look at what is currently scheduled for July, and plot the dates in July for where the senior judge will be. If something is scheduled and the senior judge will not be there to handle it, the parties will have to be notified that the hearing is canceled an must be rescheduled (and they should call back after July 12, I would suggest, to get a new hearing date).

It will be best for the senior judge schedule for July, Aug and Sept to be posted to the circuit website and procedures posted regarding matters having to be rescheduled.

I know my JA is already getting calls about the transition because the word is out that change is coming (all the circuits are beginning to see this, since this is a state-wide phenomenon). Fellow Civil Judges:

Unfortunately, I am on vacation from May 26 to June 7. If the consensus is that we should have a meeting of the civil judges to discuss shifting foreclosures to a senior judge, I will set it up. Depending on how others feel, an hour telephone meeting during lunch time may not work. Perhaps a meeting at 5:15 would be better...let's see what the consensus is. We also need to decide if we want the JA's participating in the meeting.

I need clarification from Steve and Tom as to whether the senior judges will do <u>all</u> foreclosures or just <u>residential</u> foreclosures.

My understanding is that the case managers and clerical staff will not begin work before July 1. Obviously, they will need some quick training on job responsibilities and it will take a few days for them to become familiar with the dockets and docket management.

Tom and his staff need to look at what is currently scheduled for July, and plot the dates in July for where the senior judge will be. If something is scheduled and the senior judge will not be there to handle it, the parties will have to be notified that the hearing is canceled an must be rescheduled (and they should call back after July 12, I would suggest, to get a new hearing date).

It will be best for the senior judge schedule for July, Aug and Sept to be posted to the circuit website and procedures posted regarding matters having to be rescheduled.

I know my JA is already getting calls about the transition because the word is out that change is coming (all the circuits are beginning to see this, since this is a state-wide phenomenon). I have told Lynn to advise the attorneys that the Chief Judge and Court Administrator are working out the details of how the new resources are going to be applied to the foreclosure dockets, and as soon as those plans are finalized, something will be posted to the website. I would suggest the other JA's take the same approach.

Similar to the situation already existing in SLC (I do the emergency hearings to stop foreclosure sales and postpone writs of possession since the foreclosure judge is here just a few days each month), I think the same thing will have to happen in Martin and Indian River County (that is, the civil judge will have to do the <u>emergency hearings</u> to stop sales and postpone writs of possession...and only those hearings).

So fellow judges, do we need a meeting or not? If so, lunch time or 5:15? Do we want the JA's to attend?

Dear All,

I hate to be a stick in the mud but because these cases are assigned to me I want to make sure everything is taken care of. First, am I safe in assuming that when you say foreclosures that you only mean residential foreclosures? Assuming the commercial foreclosures will stay with the circuit judge assigned to civil then I need to know how this is all going to be worked out and would like to have a meeting.

I currently have summary judgment hearings on residential foreclosures scheduled for one and one half hours on Monday of each week (approximately 40 to 60 hearings) through August, 2010. In addition to this I have on the average 6 to 12 hearings per week on my UMC calendar and I probably spend at least 1 hour a day just reviewing motions, signing orders, and scheduling hearings on residential foreclosure matters that are on my docket.

I want this to work but I don't want this to make the whole problem worse.

Paul,

I agree with you that we civil judges need to put our heads together and discuss the best way to get the maximum bang out of using a full time senior judge to handle foreclosures in the coastal counties, but I am not being kept completely in the loop. Steve has come up with a division of time that is different from what Tom told me about. Steve has made it clear to me that he wants all the civil judges out of foreclosures by July 1, but I am not sure he understands the magnitude of the problem.

I am not sure that Steve's allocation is going to give more time to spend on foreclosures in Indian River and Martin. If you and Elizabeth are inclined to continue handling some of the foreclosure dockets (maybe the commercial, non-homestead residential?), then it seems to me that maybe we will actually be tacking the backlog of cases in IRC and MC.

As you can imagine...the residential homestead docket is extremely backed up in SLC. Steve's position is that moving a senior judge to do that docket 12 days a month (instead of 5) will address will put a serious dent in the backlog.

I am attaching the filing stats on foreclosures for the 3 coastal counties (2008 and 2009). If you look at 2009, SLC had 65% of the total filings. If you look at the cumulative totals for both years, SLC had 67% of the total filings. Assuming 20 workdays a month, 65% would be 13 days each month. So if one day each week is spent for IRC and MC each, that is a total of 8 days per month. So it seems to me that the 3-1-1 split each week Steve is proposing is fair.

My understanding is that Jimmy Midelis will be handling the SLC docket and George Shahood will be handling IRC and MC, but I am not sure that has been finally decided yet. Needless to say, Jimmy will be good at moving the docket. However, my understanding is that George has been handling a few volume dockets and he does those well also.

Dear Burton.

Commercial foreclosures are completely different than residential with different hearing needs. All my questions really revolve around how are we going to accomplish this and show that we are using these resources to clear up cases (not just make our life easier). If by using the senior judges all we are doing is continuing to process cases at the same rate we currently are then we have not accomplished much.

As I said in my other e-mail, I probably spend 10-12 hours a week on all foreclosures (hearings and paperwork). If someone is going to come in and spend 6 to 7 hours per week on this then there will be little headway. I have a total of approximately open 4,500 civil cases assigned to me. Of this amount my guess is that approximately 3,000 are residential and commercial foreclosures.

I am sorry that I am so concerned about the details but I think we all need to be.
