Kenosha County Sheriff's Department is seeking assistance for Civil unrest in our city.

Currently **we are planning for staffing through the weekend (through Sunday, August 30th).**

Our needs include:

- 10 Armored Vehicles
- 20 Tactical Response Team with Chemical Munitions is desired if available
- 100+ Officers... Mobile Field Force Units (crowd control)
- 25 Patrol vehicles (more is fine with responding officers, but officers will be doubled up for assignments.
- 50 Street officers/deputies, these will be assigned to guard fire lines, block traffic, etc.

Law Enforcement will muster at the **Bradford HS football field parking lot, 3701 39th Ave.** Muster times are at 1600 & 1800 (**other times are fine, but these are targets**). 1 representative of the

responding agency/unit needs to check in at the Command Post upon arrival.
