Description of occurrence

On 08/29/2020 at about 2005 hours, while on duty as (b) (6), (b) (7)(C), (b) (7)(E), (b) (7)(F) for the Kenosha Wisconsin Protests, we were dispatched by the TOC to arrest a specific protester that was located in front of the Kenosha County Courthouse located at 912 56th St, Kenosha, WI 53140 for Curfew Violation. The description of the subject (identified after arrest as (b) (6), (b) (7)(C)) was a female wearing a red shirt and red bandana, wielding samurai swords in front of the Courthouse.

Upon arriving in the area of the courthouse, (b) (7)(E) proceeded North on Sheridan Rd past scattered groups of protesters all around in front the courthouse, in the park, and on the East side of Sheridan Road. As we drove by assessing the crowds, and looking for the subject, we saw what appeared to the be the subject on the Southeast Corner of the fencing that surrounded the building. We drove past the courthouse and parked facing South on Sheridan at the Northeast corner of the Building/Fencing. We could see what appeared to be yelling, hitting the fence with the swords, and kicking the fence on the Southeast corner. An arrest plan was formulated to approach with myself as contact, (b) (6), (b) (7)(C), (b) (7)(E), (b) (7)(F)

At about 2015 hours, (b) (7)(E) along with numerous law enforcement vehicles and personnel converged on the Southeast corner to make the arrest. Upon exiting our vehicle, we saw walking Southeast. As we approached several officers were also approaching from the Southwest giving commands to (6)(6)(6)(7)(C) to get on the ground. was facing sideways from me, trying to walk away from officers with the swords over her shoulder. Because (6)(6)(6)(7)(6) was not listening to commands, I assisted in placing (b) (6), (b) (7)(C) into a stable cuffing position on the ground. (b) (6), (b) (7)(C) then refused to place her hands behind her back, so we moved her hands behind her back for cuffing. repeatedly informed she was under arrest for curfew violation, and to listen to commands, but she resisted every command. After cuffing, (b)(0)(0)(7)(c) also refused to stand and/or walk to the transport van, so we had to carry her. Due to the exigent circumstances of being in a volatile crowd situation, we did not have time to make multiple requests hoping for eventual compliance. (b)(0),(b)(7)(c) was then searched by officers, at which time she began saying she was a lawyer, to let her go, and she would not get in the van. Because (b)(6),(b)(7)(G) refused to get in the transport van, she was lifted and placed inside. Lastly, (1) (6) (6) (7)(C) kicked my arm, hand, and fingers multiple times as I tried to hold her feet inside so the door would not accidentally close on her feet. After the door was closed, (6)(6)(7)(C) continued kicking the door and yelling. The other officers took possession of (5)(6),(6)(7)(6) property, and I left her red bandanna with the TOC. No medical attention was requested by the subject at the time of the arrest. No injuries requiring medical attention were sustained by (b) (7)(E) members. End of Report.
