Per our conversation, the USMS was asked to support Kenosha with the unrest that occurred last night after the local shooting incident. District task force member responded. The operation was led by (b) (6), (b) (7)(C), (b) (7)(F). Below is a synopsis of the text communications I received from (b) (6), (b) (7)(C), (b) (7)(F).

From text at 11:33 PM Monday

USMS has responded to Officer assist calls and several shots fired calls. When attempting to get to a shooting victim USMS took rocks and bottles and had to pull back. The area was retaken with armor, Milwaukee Incident Response Team, and USMS TF. USMS is holding an area and protecting fire crews. There are structure fires and looting.

From text at 2:02 AM Tuesday

USMS has been checking businesses and responding to looting. National Guard are protecting fire teams as well. USMS has made arrests for looting, curfew violations and burglary.

From Text 3:09 AM Tuesday

USMS TF will be exiting Kenosha in 30 minutes. USMS has been asked to return for an additional night.

I spoke this morning with (b) (6), (b) (7)(C), (b) (7)(F). Kenosha is expecting less activity tonight. A substantial number of the protestors came from Chicago and Milwaukee in response to social media posts. There does not appear to be coordinated socials post regarding tonight.

Kenosha is approximately one hour from the US Courthouse in Milwaukee. At this time the district does not foresee requesting assistance.
