**NARRATIVE**

**WITNESS STATEMENTS**

On 08/26/2020 at approximately 0019 hours, the citizen rescue was completed by West Allis Police Department SWAT. For further information see the main report by Sergeant Gold. I stayed behind with Detective Madden to make room in the armored vehicle to transport the victim Anthony M. Huber (M/W, DOB [REDACTED]) here were multiple people in the general area.

I attempted to locate witnesses standing in the immediate vicinity. Contact was made with two subjects who stated they either saw or recorded the incident in the 6100 block of Sheridan Rd.

01) Contact was made with a F/W, 25-30 yoa, 505-507, 140-150 pounds, brown hair, and brown eyes. The body camera was turned on to record her contact information. The body camera did not record the audio. It did capture the face of the female although her face was covered with a covid mask.

The subject saw a M/W, approximately 20 yoa, wearing dark clothing, baseball hat, with an AR-15 rifle running down the street. The male fell while running and eventually shot two people in the middle of the street. The subject verified both of the shot individuals had already been transported by police.

The subject stated it did not appear the male was a protester based on how he was dressed. The subject stated she was standing near the corner of 61/Sheridan when she witnessed the male shoot two people. The subject stated she was very close to the shots fired.

02) Contact was made with Tayfun Coskun (M/W, DOB [REDACTED]) of Anadolu Agency (News Agency). I took a picture of his New York issued press badge ID number [REDACTED] which expires on [REDACTED] with Detective Madden work phone. Coskun stated he captured the entire incident on camera. Coskun left the area as I spoke with another subject. However, Coskun stated he would send me the images to myself and Kenosha Police Department.

I conducted subsequent online searches which revealed Coskun did capture the incident by photograph. Below are several sources I located.
