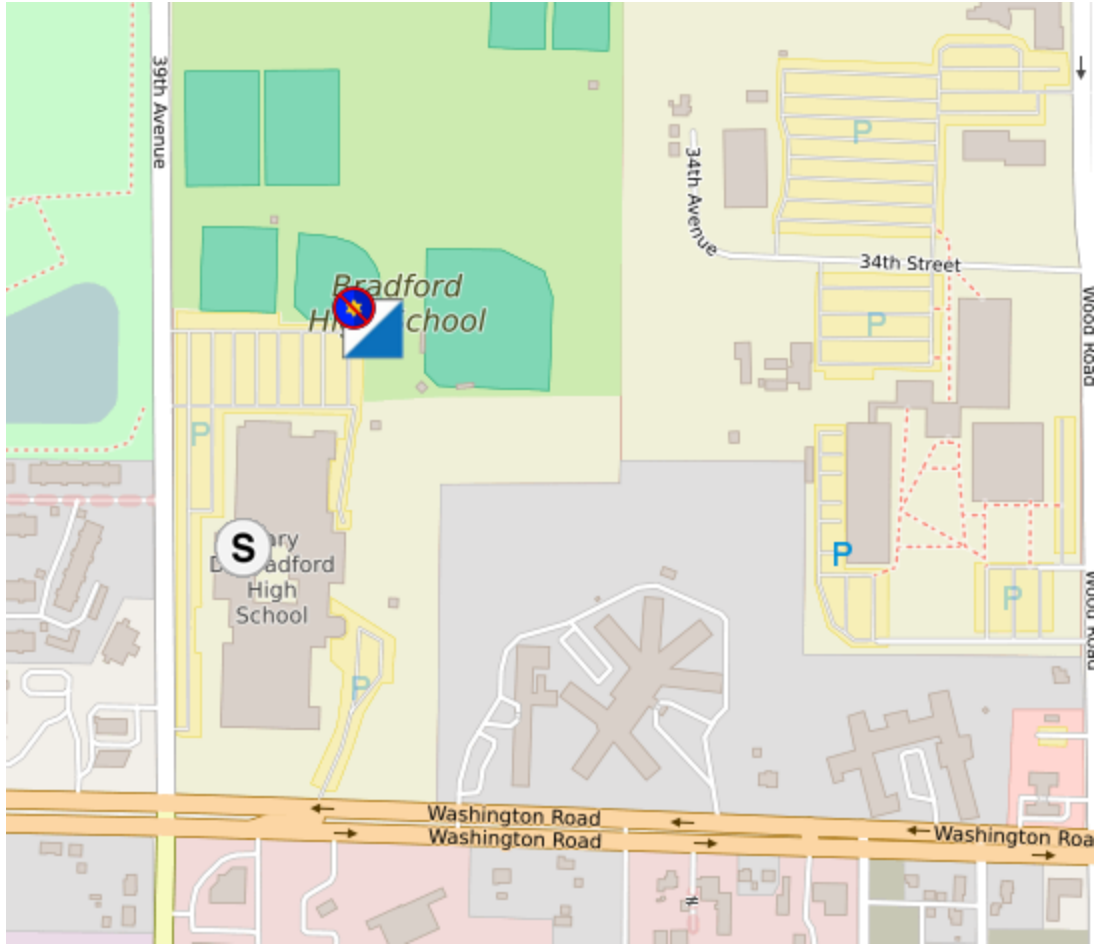

Thank you for working the Kenosha protest assignment tonight, August 25th.
Report to the staging location of 3700 Washington Road, Kenosha by 7:30pm for a briefing. You will then receive your assignment and team designation.

Please review the document attached to this email. This detail will require you to stage at the above location with your Civil Disorder gear until if/or when you may be deployed. Please bring all the appropriate equipment (attached is an inventory of what should be in your CD gear). **Uniform will be long sleeve Class D (BDU's with badge number tag).** *NO inspector uniforms or baseball caps.* Plan on bringing your own meal and snacks. There may be some at the staging area but not for sure at this time. Bottled water will be available for your use at the staging location but it's a good idea to bring extra to drink due to the heat, heavy equipment you wear, and being on your feet for a long time.

Also, make sure your portable radio is in working order, fully charged and properly programmed with **WSP Air**. If you have questions or concerns contact Sergeant Wright and Krisher.
