

Please bring all the appropriate equipment (attached is an inventory of what should be in your CD gear). **Uniform will be long sleeve Class D (BDU's with badge number tag). NO inspector uniforms or baseball caps.** Plan on bringing your own meal and snacks. There may be some at the staging area but not for sure at this time. Bottled water will be available for your use at the staging location. Also, make sure your portable radio is in working order and is properly programmed with WSP Air.
