GEORGIA LEGISLATIVE POLL

How the Poll Was Conducted

The *Georgia Legislative Poll* was conducted by Schapiro Research Group, Inc. of Atlanta, Georgia from October 13-19, 2003. A total of 500 Georgians who are registered voters were interviewed by telephone. The sample was randomly selected from voter registration lists and is stratified to represent the state's population both geographically and demographically.

The margin of sampling error for the full sample is 4.5 percentage points. This means that there is a 95% probability that the response would fall within that range if the entire population were sampled. The margin of error for subgroups is slightly higher.

Carol is a low-income woman who relies on Medicaid for her health care. She is pregnant when she finds out she has breast cancer. Her doctor says she needs chemotherapy to stop the cancer from spreading. Since the chemotherapy is likely to harm the fetus, her doctor advises her to have an abortion to protect her health. Medicaid will cover the cost of carrying the pregnancy to term, but won't cover the abortion. Do you agree with Medicaid's policy of not covering an abortion a woman needs to protect her health, or do you disagree with this policy? Is that strongly or only somewhat (agree/disagree)?

Anna is a low-income woman who is pregnant and relies on Medicaid for her health care. Routine pre-natal tests reveal that Anna's fetus has a serious genetic disorder and is likely to be stillborn. If the baby is born alive, it would likely lead a brief and very painful existence. Anna and her husband consult with their doctor and decide on an abortion because they don't want their child to suffer. Medicaid will cover the cost of carrying the pregnancy to term, but won't cover the abortion. Do you agree with Medicaid's policy of not covering abortions when a fetus has a serious genetic disorder, or do you disagree with this policy? Is that strongly or only somewhat (agree/disagree)?
