## Incident Report

██████████ I searched the area immediately in front of her residence and later located one .25 caliber shell casing. This was later impounded by Forensics as evidence.

During the interview, the victim stated that he overheard the suspect that did not have the gun call the other suspect "chuck". Investigators later identified a MySpace page belonging to ██████████ that contained several pictures of his associates. One of the associates was named "Supa Chuck". We later made contact with the Juvenile Detention Center and confirmed that "Supa Chuck" is a nickname for ██████████

Following up on investigative leads, Tallahassee Police Department records show that the suspect's telephone number ██████████ returns to a ██████████. On 04/25/08, Inv. Mahoney met with ██████████ at TPD to show him some photos. Inv. Mahoney showed ██████████ a line up that included a picture of ██████████. ██████████ immediately identified ██████████ as one of the persons who had robbed him. Mahoney also showed him a photo line up that included a picture of ██████████ aka "Supa Chuck". ██████████ was not able to identify ██████████ from the line up.

Using electronic surveillance measures, ██████████ was located at his residence at ██████████. Investigators made contact at the residence and took him into custody. ██████████ I was transported to the Tallahassee Police Department headquarters for questioning. Since he is a juvenile, his mother also came to the police station and was present during the questioning.

Post Miranda, ██████████ was questioned during the incident. He admitted to meeting some friends at the Tallahassee Skate Park where they were attempting to buy some marijuana from a "white boy", later identified as victim ██████████. ██████████ I and his friends got tired of waiting for the ██████████ to get the marijuana, so they left and walked to Stratford Landing apartments on Mission Rd. ██████████ claimed that he Supa Chuck (he later reluctantly admitted that Supa Chuck is ██████████) were trying to buy weed, not sell weed to the victim. He admitted to meeting the victim at the Chevron located at Mission Rd. and Tharpe St., and claimed that the victim was trying to get them to front him the money for the weed. ██████████ claimed that ██████████ then "lost it" and pulled out a gun and pointed it to the victim's head. ██████████ claimed that the victim and ██████████ struggled over the gun while he got out of the vehicle. He denied taking any of the victim's property and claimed not to know if ██████████ had taken any of the items or not.

██████████ claimed that he and ██████████ got out of the vehicle and starting walking away while the victim drove off. A short time later, they encountered the vehicle again and ██████████ claimed that the ██████████ sped up while driving towards them down the road, and that's when ██████████ pulled out his gun and fired a shot at the vehicle as it drove by. ██████████ claimed that he and ██████████ ran off and ended back at Stratford Landing, where he caught a ride and went home. ██████████ was subsequently charged with Robbery and transported to JAC.

I later made contact with suspect ██████████ via telephone. ██████████ called my phone and wanted to speak with me about this incident after hearing that ██████████ had been arrested. ██████████ did not have any way of getting to the police station, so I agreed to go and pick him up at the 2600 blk of Mission Rd. at Angels Convenience Store. Myself and Inv. Wester drove out there and picked up ██████████ and drove him back to the station. ██████████ mother, ██████████, was notified by telephone and indicated that she "might head up that way" to the police station where we were at. Based on my conversation with her, my impression was that she was not overly concerned about her son being questioned by the police.
