Thank you for your detailed update.

I would be happy to limit the date range of the searches and modify the search terms to make this more manageable.

For item (e), how about searching for "Harris Corporation" and "Harris Corp." instead of just "Harris" – that should eliminate files that include someone named "Harris".

I am also willing to eliminate items (j) and (k) – while those terms would reveal responsive records, if any exist, they would also pick up other forms of cell phone tracking that we are not asking about – specifically, requests to cell service providers for historical or real-time cell site location information. To keep the processing time down, let's eliminate those search terms.

For a date range, could you provide an estimated processing time and cost for a search of records from January 1, 2010 to the present? I'm open to further negotiation, depending on the estimate you and your Data Services Manager are able to provide.

Good morning Mr. Wessler,

I am contacting you to provide an update on your public records request. I apologize for the delay in responding; our Data Services Manager has been out of the office and I was waiting for her to return so she could conduct a search of our databases based on the list of proposed search terms you provided. A search of our Vice and Narcotics database produced no records responsive to your request, with the exception that the term "Harris" appeared as an individual's last name in several reports (which is not responsive to the nature of your request based on our telephone conversation). With regard to a search of records management database for all other agency reports (not specific to the Vice and Narcotics Unit), our Data Services Manager has informed me that once matches are found in the narrative portion of reports, each report would then need to be reviewed for content to see if it is responsive to your request. As an example, she stated that a search for "kingfish" produced reports that referenced Kingfish Lane. She also indicated that "j" and "k" in your request will take quite a bit of time to search each possible combination, and the same individual review of content would be required.

I asked her to provide an estimate of the number of reports and labor time associated with responding to your request, and she indicated it is quite difficult due to the nature of the search and requested terms. As an estimate for example, she said that a search of "cell phone" and "track" for the year 2013 produced 214 reports; a search of "harris" for 2013 produced 522 reports; and a search of "kingfish" for 2013 produced 8 reports. All would need to be individually reviewed to see if it was responsive to your request (i.e. rather than the term being a last name, street name, etc.). As you can see, searching for only three of your requested terms produced 744 reports for just one year and each of these reports needs to be manually reviewed by staff. Since you did not provide a date range, this process will be extremely time consuming and require an extensive amount of labor.

If you would like our agency to respond to your request as stated below, please let me know and I will attempt to provide, as best as possible, a good-faith estimate of costs associated with the request and we will require a down payment to commence work on the request. If you would like to further narrow down your request, please let me know and I will proceed accordingly.

Thank you for your response, and for your time on the phone this afternoon. Pursuant to our discussion, here is a list of proposed search terms to use in an electronic search of investigative files:

- a. stingray;
- b. kingfish;
- c. hailstorm;
- d. triggerfish;
- e. Harris;
- f. "cell site simulator";
- g. "cell-site simulator";

- h. "cell site emulator";
- i. "cell-site emulator";

To the extent an electronic search can deal with connected term searches like these, then I would also add:

- j. ("cell phone" or "cellphone") & (track, tracking, tracked);
- k. ("cell phone" or "cellphone") & (locate, located).

As we also discussed, it would be helpful if you would ask the appropriate people in the Major Crimes division whether they have knowledge or recollection of any investigations where the Sheriff's Office used cell site simulator-type technology. If they do, then a diligent effort to identify case files related to such investigation(s) would be appreciated.

Dear Mr. Wessler,

The Pasco Sheriff's Office is in receipt of your public records request regarding use of cell site simulators. Regarding the items as described in #1 - #6 and #8 of your letter, there are no documents responsive to your request. Regarding the items as described in #7, #9 and #10 of your letter, please be advised that this agency does not keep any such records filed or organized by whether a cell site simulator was used in an investigation. Our investigations are filed by case number and agency personnel would have to review every investigative file for content to determine whether we have any records that are responsive to your requests #7 - #10. You did not provide a date range so as you can imagine, there are likely tens of thousands, if not hundreds of thousands, of investigative case files and documents that would have to be reviewed. This would likely result in extensive labor fees and costs to respond to your request.

If you would like to narrow your request to a specific date range, specific case numbers or specific type of investigation, we will promptly begin working on researching and responding to your request. If you would like to keep your request as presently worded, please advise and I will work on gathering an estimate of the labor time and cost associated with responding to your request.

Additionally, please be advised that with respect to the portion of your requests to provide documents in investigations that have resulted in prosecutions (#7) and docket numbers for records that are sealed (#9), our agency would not have that information as we do not maintain a database or other records of this nature. The State Attorney's Office and/or Clerk of Court would likely be the proper party to whom you should direct such requests.

I look forward to hearing from you with instructions how you would like for our agency to proceed with processing your request. In the meantime, if you have any questions or concerns, please do not hesitate to contact me.
