This is regarding the estimate of fees responsive to items 9 and 10 from January, 2010 to present of your records request for cell site simulators. We do not possess or have purchased a cell site simulator, therefore; we do not have records in reference items one through seven.

We do not possess records in reference to a list of criminal cases, in which cell site simulators were used.

Item nine needs extensive research on a case by case basis. We do not have any indication as to what specific cases are involved with cell site simulators, applications for search warrants, orders authorizing cell site simulators, denials of warrants or any order involving the use of cell site simulators. Furthermore, the case load to be researched is undetermined as well as the amount of time (labor and personnel) dedicated to this research. Also, it would be helpful to have a starting date and ending date of what cases to search. We are unable to estimate production and labor costs at this time; however, it would be extensive.

Item ten needs extensive research on a case by case basis. We do not know which closed investigations involved the use of cell site simulators. Every case would need to be read to locate the specific record about cell site simulators. The case load to be researched is undetermined as well as amount of time (labor and personnel) dedicated to this research. We are unable to estimate production and labor costs at this time; however, it would be extensive.
