Dear Liam,

We are writing to raise a new case of non-compliance. Class counsel recently spoke with counsel representing class member Fabrice Nsabimana, who is currently at basic combat training at Fort Sill, Oklahoma. Mr. Nsabimana first obtained his N-426 certification through his chain of command in October 2021 and applied for naturalization with United States Citizenship and Immigration Services ("USCIS") shortly thereafter. On December 10, 2021, USCIS rejected Mr. Nsabimana's naturalization application because the certifying officer left box 4 of Part 8 of his N-426 form blank. Last week, Mr. Nsabimana requested a new, properly certified N-426 form from his drill sergeant, who told him that he will move it up the chain of command after the holidays. However, USCIS has only given Mr. Nsabimana until January 9, 2022 to submit a new N-426 certification.

Class counsel request that Defendants assist with certification of Mr. Nsabimana's N-426 form, which is attached to this letter. Mr. Nsabimana's current unit is

Last week, class counsel also spoke with counsel representing class member Yiyi Yu. Class counsel wrote to Defendants on December 9, 2021 about Ms. Yu's situation, explaining that Ms. Yu had received an N-426 certification on November 22, 2021, but that the certifying officer left box 4 of Part 8 of her N-426 form blank. On December 13, 2021, Ms. Yu obtained a completed N-426 form through her chain of command and submitted that form to USCIS shortly thereafter. However, USCIS has rejected this N-426 form because the footer of the form, which indicates the form's expiration date, is not visible. Last week, Ms. Yu submitted another N-426 form to her chain of command for certification. However, she was informed that she should not expect the certification back for a while because of vacation schedules. Class counsel would be grateful if Defendants could assist with expediting the certification of Ms. Yu's new N-426 form. Class counsel will send this N-426 form once we have it.
