(U) I, LEON E. PANETTA, hereby declare:

I. (U) INTRODUCTION

1. (U) I am the Director of the Central Intelligence Agency ("DCIA") and have served in this capacity since 13 February 2009.¹ As DCIA, I serve as the executive head of the CIA pursuant to the National Security

2. (U) Through the exercise of my official duties, I have been advised of this litigation and I have read the Complaint filed in this case. I make the following statements based upon my personal knowledge and information made available to me in my official capacity. The judgments expressed in this declaration are my own.

(U) The purpose of this declaration is to formally assert and claim the state secrets privilege, as well as relevant statutory privileges under section 102A(i)(1) of the National Security Act of 1947, as amended, and section 6 of the CIA Act of 1949, as amended, to protect intelligence activities, sources, and methods that may be implicated by the allegations in the Complaint

Dual U.S.-Yemeni citizen

Anwar al Aulaqi ("Aulaqi") is one of the world's most dangerous terrorists. As the chief of external operations for al-Qa'ida in the Arabian Peninsula ("AQAP"), a Yemen-based regional node of al-Qa'ida, Aulaqi is responsible for the planning and execution of terrorist attacks against the United States, our allies, and American interests worldwide. Although perhaps best known for his pivotal role in AQAP's attempt to blow up a U.S. airliner bound for Detroit on December 25, 2009, Aulaqi continues to seek to recruit, vet, and train other terrorists for future attacks against the U.S. Homeland. Indeed, no other member of AQAP possesses Aulaqi's near-celebrity status (he is a well-known Islamic scholar), his English-language abilities, or his knowledge of the West (he was born and educated in the U.S.). These characteristics make him a particularly effective recruiter and advocate for al-Qa'ida's violent ideology.

30. (U) Section 102A(i) (1) of the National Security Act of 1947, as amended, 50 U.S.C.A. § 403-1(i) (1) (West Supp. 2010) (the "NSA"), provides that the DNI "shall protect intelligence sources and methods from unauthorized disclosure." Pursuant to section 102A of the NSA, as amended, 50 U.S.C.A. § 403-1(i), and consistent with section 1.6(d) of Executive Order 12333,⁹ the CIA is authorized to protect intelligence sources and methods from unauthorized disclosure.
