13 inspection on or before **July 11, 2017;**
- 14 4. Objections to exhibits shall be filed and served on or before **August 1,**
15 **2017;**
- 16 5. Designation of substantive deposition testimony of witnesses who will
17 be unavailable to give live testimony at trial shall be served on or
18 before **July 11, 2017.** Cross-designations shall be served on or before
19 **July 25, 2017.** Objections to any designated deposition testimony
20 shall be filed and served on or before **August 1, 2017;**
- 21 6. All motions *in limine* shall be served and filed not later than **July 11,**
22 **2017,** and shall be heard and resolved at the pretrial conference;
- 23 7. Trial briefs, requested jury instructions, and requested jury voir dire
24 shall be filed and served on or before **August 1, 2017;**
