

THE PRIORITY FOCUS OF THE ONGOING INTERROGATIONS OF DEFER TO HQS FOR APPROPRIATE COORDINATION WITH FEI H	ABU ZUBAYDAH.	

- 2. AS ALL ARE AWARE, ABU ((ZUBAYDAH)) (SUBJECT) HAS NOW BEEN IN CUSTODY FOR ONE MONTH. CAPTURING THIS SENIOR AL-QA'IDA OPERATIVE AND DEPRIVING THE ORGANIZATION OF HIS LEADERSHIP AND COMMAND WAS A TREMENDOUS ACCOMPLISHMENT AND HAS NO DOUBT DEALT A TREMENDOUS BLOW TO

AL-QA/IDA AND POSSIBLY EVEN DISRUPTED ONGOING TERRORIST ACTIONS. THE THREAT, HOWEVER, HAS NOT DIMINISHED. SUBJECT HIMSELF HAS NOTED THAT IN RESPONSE TO HIS ARREST, HIS "BROTHERS" WILL ADJUST AND ADAPT. SINCE DAY ONE OF HIS ARREST, THE MAIN OBJECTIVE AND FOCUS OF THE INTERROGATION OF SUBJECT HAS BEEN TO OBTAIN CRITICAL INFORMATION ON HIS KNOWLEDGE OF THREATS TO OUR INTERESTS - BOTH INSIDE AND OUTSIDE OF THE UNITED STATES, WITH THE INTENT OF COLLECTING SUFFICIENT DETAILS ON THESE ISSUES TO EFFECTIVELY COUNTER SUCH THREATS.

3. FACTORING IN THE TIME SPENT ATTENDING TO SUBJECT'S MEDICAL CONDITION, THE ACTUAL SYSTEMATIC INTERROGATION OF SUBJECT HAS BEEN ONGOING FOR 12 DAYS. DURING THIS TIME, THE INTERROGATION TEAM, WORKING IN COORDINATION WITH HEADQUARTERS, HAS ATTEMPTED TO COLLECT CRITICAL THREAT INFORMATION BY EMPLOYING VARIOUS CONDITIONING FACTORS. THESE TACTICS HAVE MET WITH A VARYING DEGREE OF SUCCESS AND THE INTERROGATION OF SUBJECT HAS RESULTED IN THE DISSEMINATION OF INTELLIGENCE REPORTS ON A VARIETY OF TOPICS. SPECIFICALLY CONCERNING THREAT-RELATED INFORMATION, SUBJECT HAS PROVIDED DETAILS OF THREE POTENTIAL PLANS TO TARGET U.S. INTERESTS: 1) THE POTENTIAL THREAT TO CROWDED PLACES IN THE UNITED STATES, TO INCLUDE U.S. FINANCIAL INSTITUTIONS; 3) THE REPORTED PLAN FOR AL-QA'IDA OPERATIVES TO BUILD A RADIOLOGICAL OR URANIUM ENHANCED EXPLOSIVE DEVICE TO BE DETONATED IN AN UNSPECIFIED U.S. LOCATION, AND 3) A PLAN INITIATED BY SUBJECT TO REMOTELY DETONATE EXPLOSIVES IN U.S. RESIDENTIAL APARTMENT BUILDINGS TO FACILITATE THE RELEASE OF SHAYKH 'UMAR 'ABD AL-((RAHMAN)).

THESE CHANGES HAVE INCLUDED INITIATING PERIODS OF SLEEP DEPRIVATION,
