

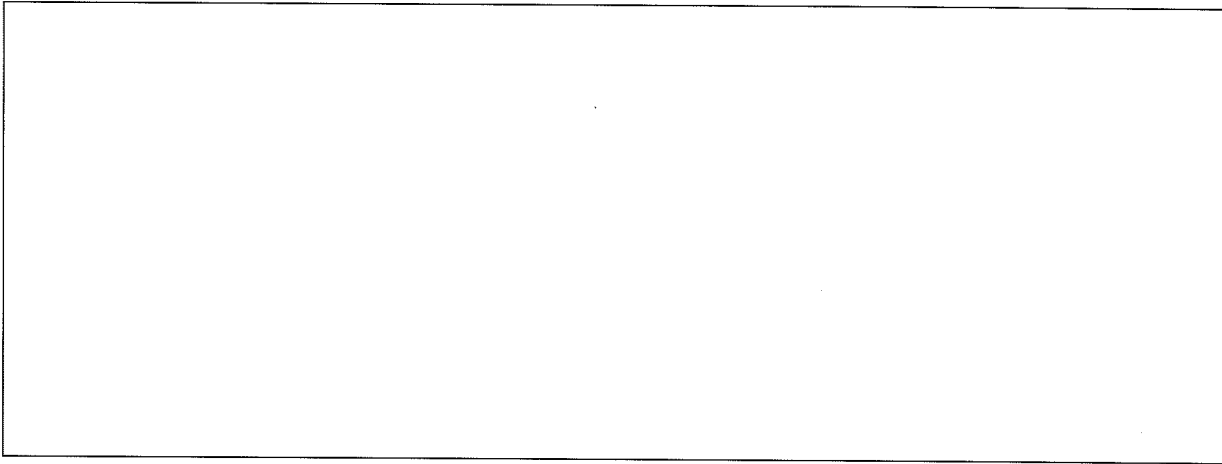

1. ACTION REQUIRED: FOR HQS REVIEW. SEE PARA (4) BELOW.
2. [Redacted] ASSESSMENT / STATUS: AS OF 23 AUGUST, AN FOLLOWING 19 DAYS IN THE AGGRESSIVE PHASE OF INTERROGATION, [Redacted] TEAM ASSESSMENT IS THAT WE HAVE SUCCESSFULLY BROKEN SUBJECT'S WILLINGNESS TO WITHHOLD THREAT AND INTELLIGENCE INFORMATION. HE IS PRESENTLY IN A STATE OF COMPLETE SUBJUGATION AND TOTAL COMPLIANCE. WE COLLECTIVELY HAVE REVIEWED ALL AVAILABLE INTELLIGENCE REQUIREMENTS,

AND THUS FAR HAVE NOT IDENTIFIED ANY SPECIFIC/SPECIFIC ISSUES UPON WHICH WE CAN DEFINITELY ASSESS THAT HE IS PURPOSEFULLY OR ACTIVELY HOLDING BACK OR NOT COOPERATING. INTERROGATION TEAM AT [REDACTED] ASSESSES THAT SUBJECT HAS NO THREAT INFORMATION NOT ALREADY PROVIDED. COB NOTE: THE ISSUE OF WHETHER SUBJECT IN FACT HAS SPECIFIC THREAT INFORMATION (NOT ALREADY PROVIDED) WILL ALWAYS BE OPEN TO SOME CONJECTURE. THE AGGRESSIVE AND COMPREHENSIVE NATURE OF PROGRAM ALREADY CONDUCTED FOR THE LAST 19 DAYS HAS PROVIDED [REDACTED] WITH A VERY HIGH DEGREE OF CONFIDENCE THAT SUBJECT HAS REVEALED (AND WILL C THREAT

DATA, OR IS PERSONALLY INVOLVED IN A CURRENT OPERATION HE HAS NOT YET REVEALED, OUR ASSESSMENT WOULD OBVIOUSLY CHANGE. AT THAT TIME, WE WOULD NEED TO ADDRESS THE EMPLOYMENT OF ALTERNATIVE STRATEGIES.
