TEXT:

1. ACTION REQUIRED: PLS SEE SEPARATE CABLE RE FULL DETAILS OF RESULTS OF 10 AUGUST INTERROGATION SESSIONS.

2. OVERALL STATE OF PLAY: [redacted] AS OF THIS REPORTING PERIOD, AFTER IMPLEMENTING A VARIETY OF APPROVED TECHNIQUES INCLUDING THE WATER BOARD, ((ABU ZUBAYDAH)) (SUBJECT) HAS CONTINUED TO DENY ANY KNOWLEDGE CONCERNING ANY NEW THREAT-RELATED INFORMATION RE THREATS AGAINST THE UNITED STATES AND DID NOT MAKE ANY REVELATIONS RE NEW THREATS. THE TEAM'S ASSESSMENT REMAINS THE SAME [redacted] ON 10 AUGUST 02 -- DAY SEVEN OF THE AGGRESSIVE INTERROGATION PHASE -- THE TEAM BEGAN WITH A STAFF MEETING TO REVIEW THE STRATEGY FOR THE DAY'S CYCLE OF INTERROGATION SESSIONS.

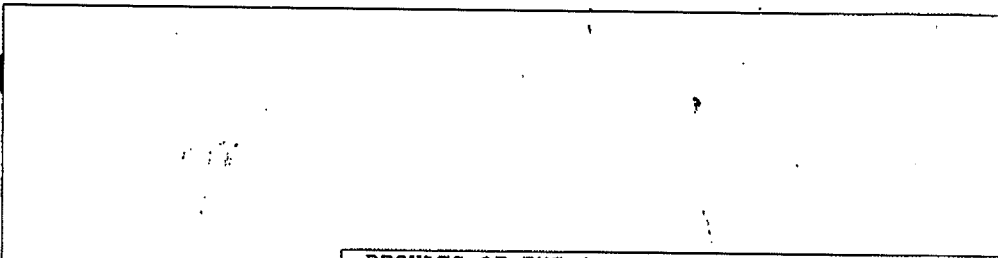

RESULTS OF THE QUESTIONING BEING ADDRESSED IN SEPARATE TRAFFIC.

3. ATMOSPHERICS/BEHAVIORAL COMMENTS: TODAY'S SESSIONS INVOLVED INTERROGATION ON THE WALL, USE OF THE WATER BOARD AND MORE QUESTIONING ON THE WALL DURING THE LATTER PART OF THE DAY WITH PERIODS IN WHICH SUBJECT SPENT TIME IN THE LARGE CONFINEMENT BOX AND THE SMALL CONFINEMENT BOX. WE SHOULD EMPHASIZE THAT AS DONE SINCE DAY ONE OF THIS INTENSIVE PHASE OF THE INTERROGATIONS, SUBJECT WAS EXPOSED TO AT LEAST ONE OF [] APPROVED PRESSURES 24 HOURS A DAY.

4. THREAT UPDATE: NO NEW THREAT INFORMATION TO REPORT AS OF THIS WRITING.

5. MEDICAL UPDATE: SUBJECT IS MEDICALLY STABLE. WOUND DIRECTLY VISUALIZED AND IS WITHOUT SIGNIFICANT BREAKDOWN IN THE PAST TWENTY-FOUR HOURS. NUTRITION, HYDRATION AND WOUND CARE REMAIN DEQUATE.
