PLAINTIFFS' MOTION FOR TEMPORARY RESTRAINING ORDER AND PRELIMINARY INJUNCTION

Pursuant to Rule 65(a) and (b) of the Federal Rules of Civil Procedure, Plaintiffs respectfully move the Court for a temporary restraining order and preliminary injunction to prohibit Defendant City of Fremont, Nebraska, from enforcing or implementing Ordinance No. 5165, the Immigration Ordinance approved by voters on June 21, 2010. The City of Fremont has stated its intention to begin enforcement of the Immigration Ordinance on July 29, 2010.

GROUNDS FOR APPLICATION

The Immigration Ordinance unlawfully usurps the federal government's exclusive authority to regulate immigration by restricting residence in the City based on immigration status and mandating participation in an employment verification program that Congress has expressly left voluntary. As set forth more fully in the accompanying memorandum in support of this motion, Plaintiffs are likely to prevail on the merits of the claim, among others, that the Ordinance violates the Supremacy Clause of the U.S. Constitution, and that the Ordinance exceeds the City's municipal authority under Nebraska law.

Unless the Ordinance is enjoined, Plaintiffs will be irreparably harmed because they will face criminal prosecution and penalties unless they comply with the unconstitutional law, as well as threatened loss of their homes or separation of family, and loss of livelihood, in addition to the burdens of compliance and other harms.
