Declaration of Bothaina Hassoun

I declare under penalty of perjury pursuant to 28 U.S.C. § 1746 that the following is true and correct:

- My name is Bothaina Hassoun.
- I am a U.S. citizen and have lived in Sunrise, Florida, for the last 30 years and have been in the United States since 1982.
- Adham Hassoun is my brother. I grew up with Adham, and he lived with me in Florida from 1989-1992 after he moved to the United States. He then moved next door, where he lived with his wife and kids from 1993-2002.
- After Adham was arrested in 2002, I visited him regularly until 2008 when he
 was moved to Colorado. From 2008 until now, I have kept in touch with him by
 phone.
- My brother and I talk regularly. Sometimes twice a week, sometimes every day. In all the time that I have known him, my brother has never said anything in support of violence against innocent people or in favor of any terrorist organization.
- My brother is an outgoing, friendly, sociable person. He loves to be surrounded by people. Before his arrest, he loved going to the park on weekends, and he would plan events like the company Christmas party.
- 7. When he lived in Florida, people knew him as someone who loves to help people. You ask him to do anything, he will do it. People knew that he was generous with his time and money. He loves giving advice, and if he has \$50 dollars and you need it, he will give it to you.
- My brother is also religious. He is a regular Muslim, not an extremist. He does not believe that Islam permits violence against innocent people, and he would never agree with someone who did.
- When my brother is released, I will ensure that he is provided for. As the U.S.
 government knows, I provide funds to his commissary account periodically to
 cover his needs. Under no circumstances would I allow him to go hungry,
 especially after all he has suffered.

- 10. I have lived in Florida the last 30 years, and I plan to continue living in Florida for the future. I live in a three-bedroom, single family home in a neighborhood of similar homes surrounded by lakes, in the town of Sunrise, near Fort Lauderdale. I am usually home during the day, though sometimes I go shopping or have appointments, and my brother is welcome to live with me for as long as he needs.
- 11. When my brother lives with me, I am happy to do what I can to help him comply with the conditions the Court decides, including limiting visitors to the house. I just want my brother to be home with me.
- 12. The only people who live with me in the house are my son, daughter-in-law, and my grandson. My other son and daughter-in-law and grandson sometimes visit, and so does my ex-husband. I understand that the government has approved these people to visit the house when my brother will be living with me.
- 13. In all the years I have known my brother, I am certain he is no danger to anyone. He does not have extreme religious views like the government says. He is a normal Muslim man with a good relationship with his family and community.
