DECLARATION OF ELIZA SWEREN-BECKER

I, Eliza Sweren-Becker, pursuant to 28 U.S.C. § 1746, declare as follows:

1. My name is Eliza Sweren-Becker. I am an attorney with the American Civil

Liberties Union Foundation and counsel for Plaintiffs in this litigation. I am familiar with and have personal knowledge of the facts set forth herein and could and would testify competently thereto if called upon to do so.

2. I submit this declaration in support of Plaintiffs' Cross-Motion for Summary

Judgment and Opposition to Defendant's Motion for Partial Summary Judgment.

3. Plaintiffs submitted a Freedom of Information Act ("FOIA") request on March 10, 2015 for the legal opinion concerning "common commercial service agreements" authored by the Department of Justice's Office of Legal Counsel ("OLC Opinion or Opinion").

4. The government has withheld the Opinion in full under FOIA Exemption 5, 5 U.S.C. § 552(b)(5), specifically the deliberative-process and attorney–client privileges, and Exemptions 1 and 3, *id.* § 552(b)(1), (b)(3).

5. The government has provided extremely limited factual information about the requested record. The factual information is limited to two paragraphs in the Colburn Declaration, *see* ¶ 11–13.

6. Among other things, the government has not provided information about the circumstances related to the creation of the OLC Opinion; the agencies or executive branch components that requested or received the Opinion; any other circulation or distribution of the Opinion; whether and how any agencies or components used or relied on the Opinion; and whether and how any agencies or components continue to rely on the Opinion.
