Good morning, Colleagues:

I am pleased to report a significant advancement in the business processes that govern privacy, retention, and redress issues associated with SAR information being provided to the FBI Guardian system. Attached is a letter from U.S. Deputy Attorney General James M. Cole outlining new retention schedules for records in the Guardian system. The NSI PMO is of the opinion these new policies by the FBI will address Fusion Center concerns about pushing their vetted SAR records to the eGuardian system. Additional guidance (also attached to this email) has been provided in the form of an FAQ.

I will be scheduling regional calls with all Fusion Centers next week to address any additional questions you might have regarding these policy changes. During this call, representatives from the FBI, DHS, and the NSI PMO, will be available to share further information, address remaining questions, and update you on technology enhancements that will provide improvements to NSI functionality.
