DECLARATION OF AARON R.  
PETTY IN SUPPORT OF  
DEFENDANTS' MOTION FOR  
RECONSIDERATION

HON. RICHARD A. JONES

I, Aaron R. Petty, declare under penalty of perjury as follows:

1. On July 3, 2017, I visited U.S. Citizenship and Immigration Services's ("USCIS") website at <<https://egov.uscis.gov/cris/processTimesDispInit.do>>.

2. By clicking on the button labeled "Field Office Processing Dates" and "Service Center Processing Dates" for each Field Office and Service Center, respectively, I was directed to a screen that provided the "Processing Cases As Of Date" for associated with the various applications processed at each Field Office and Service Center.

3. Based on information and belief, the "Processing Cases As Of Date" indicates the most recently filed applications that are currently being adjudicated for each application

1 type at each office. For example, for Form I-485s filed at the Agana, Guam Field Office,  
2 the “Processing Cases As Of Date” is November 13, 2016. This means that Form I-485s  
3 filed with that office on or before November 13, 2016 are currently being adjudicated,  
4 while applications of that type filed after November 13, 2016 are not yet being  
5 adjudicated.

6 4. The “Processing Cases As Of Date” for each Field Office and Service Center for  
7 Form I-485 and Form N-400 are listed in the attachment. These dates reflect those listed  
8 on the USCIS website on July 3, 2017, which at that time had been last updated on June  
9 29, 2017 and reflect the “Processing Cases As Of Dates” that were accurate as of April  
10 30, 2017.
