Ms. Stock,

To update you about the status of the N-426. Your Soldier is "fleet of foot," and the timing complicates getting that N-426 signed because he's been part of 3 Brigades in the past month.

The unit you originally contacted in Arkansas was either NG or Reserve and is no longer his unit, as he has apparently gone active duty, so they are no longer his chain of command to get the signature. That's why there was no real response from them.

When Fort Benning LAO was contacted, SPC Zong had just in-processed with the in-processing MEPS station which is the 30<sup>th</sup> AG under the 194<sup>th</sup> Adjutant Brigade.

No problem, but he was only there for about 5 days and was then assigned to one of our three training brigades, the 197<sup>th</sup>, 198<sup>th</sup> and the 199<sup>th</sup> (Infantry and Armor). The 30<sup>th</sup> did not know which one, as he was off their books.

So I reached out to those Brigades he is assigned to, to get the correct Brigade Commander. That involved a series of phone calls to CQ duty desks and then S-1 shops in each Brigade.

I have discovered that SPC Zong is now with the 197<sup>th</sup> Brigade. I have reached out to their paralegal for help. I will keep you posted.
