JOINT STATUS REPORT

17 The parties jointly submit this status report pursuant to the Court’s June 18,
18 2020 order (ECF No. 59).

19 *Defendants That Have Completed Document Productions*

20 Consistent with the June 18 order, the parties conferred regarding the
21 production of draft *Vaughn* indices by Defendants U.S. Customs and Border
22 Protection (CBP), U.S. Immigration and Customs Enforcement (ICE), and U.S.
23 Citizenship and Immigration Services (USCIS). Following that conferral process,
24 CBP and ICE provided Plaintiffs with partial draft *Vaughn* indices, and USCIS
25 provided Plaintiffs with a “Sample Redaction Index,” on August 20, 2020. USCIS
26 has also determined that it will reprocess some of the records previously produced

1 to Plaintiffs and aims to complete the reprocessing, and provide the reprocessed
2 records to Plaintiffs, by September 30, 2020.

3 The parties proposed, and the Court has entered, a schedule for partial
4 summary judgment briefing regarding the redactions and withholdings by CBP,
5 ICE, and USCIS (ECF No. 72). Prior to the start of that briefing, the parties intend
6 to confer in an attempt to narrow the redactions and withholdings in dispute.

7 *Remaining Defendants*

8 The status of the remaining Defendants' processing of Plaintiffs' FOIA
9 request and production of responsive records is set forth in the parties' joint status
10 reports of August 24, 2020 (ECF No. 67) and July 23, 2020 (ECF No. 65). During
11 a telephonic hearing on September 8, 2020, Judge Illman addressed disputes raised
12 in those status reports regarding the processing of the request by the State
13 Department and the Department of Homeland Security's Privacy Office. Judge
14 Illman directed the Plaintiffs to prepare a proposed order, noting any objections
15 from Defendants, to be filed by September 14, 2020 for Judge Illman's review.
