

COMMANDERS AND CERTIFYING OFFICIALS ARE NOT PERMITTED TO IMPOSE LOCAL RESTRICTIONS OR PREREQUISITES, SUCH AS MINIMUM TRAINING OR SERVICE REQUIREMENTS, AS A CONDITION OF CERTIFYING HONORABLE SERVICE.
