Dear Judge McMahon:

Plaintiffs write on behalf of both parties in the above-referenced matter to respectfully request that the Court enter final judgment in this case.

On August 8, 2016, this Court issued a Memorandum Decision and Order concerning Prongs 1 and 2 of Plaintiffs' October 15, 2013, FOIA request. *See* ECF No. 83. On August 16, 2016, the Court issued a Directive instructing the parties to inform the Court how they wished to proceed on the remaining claims (Prongs 3 and 4). *See* ECF No. 84. On September 6, 2016, the parties informed the Court by letter of their agreement to conclude the litigation before this Court and to file a motion dismissing the remaining claims with prejudice. *See* ECF No. 89. On September 9, 2016, the parties filed a Joint Stipulation and Order of Dismissal of Complaint, *see* ECF No. 92, which the Court signed on September 12, 2016, *see* ECF No. 93.

As the Government noted in its letter of October 20, 2016, updating the Court as to the status of this and related litigation, *see* ECF No. 94, judgment has not yet been entered in this case. The parties respectfully request that the Court enter final judgment.
