1 This Court, pursuant to Defendants' Motion to Compel IMEs and Depositions and
2 for Relief from Related Deadlines, and for good cause shown, hereby **ORDERS:**

3 Defendants' Motion to Compel is **GRANTED**.

4 1. Plaintiffs Suleiman Abdullah Salim and Mohamed Ahmed Ben Soud
5 will submit to independent medical examinations and attend depositions in the
6 United States no later than January 17, 2017;

7 2. Plaintiff Obaid Ullah will attend a deposition in the United States no
8 later than January 17, 2017; and

9 3. This Court's scheduling order, ECF No. 59, shall be amended as
10 follows:

- 11 • Defendants shall be afforded until the latter of two-weeks after an
12 IME or deposition is completed within which to produce a
13 Fed.R.Civ.P. 26(a)(2)(B) report from each of their experts that
14 conducts an IME.
- 15 • Plaintiffs shall be afforded until two-weeks after services of a report
16 from Defendants to serve a rebuttal report.
