My wife submitted her N-426 to her chain of command, along with the attached memorandum from the Department of the Army, on 10 SEP 20. We have not received any update from her chain of command, and her recruiter has not been able to provide any information about where he sent the document for signature, nor provided any documentation regarding who is in her chain of command.

We followed up with the CalGuard JAG office and were told that the California Army National Guard was not bound by the order because it came from a court in Washington, DC. When I protested, the JAG officer I spoke with then threatened to certify my wife's service as "dishonorable," based on her time in service not meeting the 2017 DOD memorandum time in service requirements, if I attempted to pursue the issue any further.

My wife attempted to submit her N-426 and the 2020 Memorandum to her chain of command at Fort Jackson's basic training inprocessing center on 24 SEP 20 with a request to speak with legal services, and the drill sergeant stated "we are in COVID, we don't have time or people to handle this." The drill sergeant read the documents and stated "this says it applies to the reserves, not the National Guard." She showed him 10 U.S.C. § 10101 defining the Reserve components of the Army as including the National Guard, and the drill sergeant still refused her request. She is now in red phase in basic training and can no longer communicate with me.

I spoke with Sana Mayat from the ACLU and she told me to send my wife's N-426 and related documents to this email. I have attached my wife's executed power of attorney authorizing to speak on her behalf, a DA4187 listing her dates of service, and enlistment contract. Please let me know if you need any further documentation from us. Thank you for your help.

Good morning Sana,

We had an issue with the N426. Our attorney submitted Darya's N400 and N426 to USCIS for processing on Nov. 2. Yesterday, they sent us a RFE stating that the N426 we sent in was the "old" version. What we submitted was the version we downloaded from the USCIS website on the day that we filled it out (7/10/2020). USCIS is taking the position that the Form N426 posted on their website that day has been out of date since 7/31/2019. USCIS claims that they had already released the updated N426 on 9/16/2019 (45 days after the old N426 officially expired).

I tried calling the USCIS military helpline and the help line would not allow me to reach a representative no matter what I said. After asking for a representative, the automated system asks you why you want to speak with a representative. I tried "document problems," "deployment," "request for evidence," "something else," "that didn't help," "representative," "agent," "what can I talk to an agent about?," "I still need help," "other," "command refuses to sign documents," and "appeal." I attempted all of these inputs between 7:32am and 7:49am Pacific across 5 calls. Each time, the system tried to refer me to the website, to send me an email or text message with a form, or stated "it seems I cannot help you, so I am going to disconnect the call." I do not believe they have any options that allow you to speak to a representative.

One thing I know about military chains of command is that high

ranking officers become irate if they have to resign a document due to someone else's mistake. This will result in many commanders refusing to sign a second N426 or retaliating against the soldier for making a mistake with the forms. I would anticipate many denials coming from this result unless someone can

Could you please send him the N426 he signed and the new, completed N426 for his signature? I do not have an alternative method of getting the document to him that does not result in me "skipping the chain of command" and getting Darya into trouble.
