This motion for partial summary judgment pertains to the Defense Department's withholding of certain information responsive to the FOIA request and the Central Intelligence Agency's refusal to process the FOIA request. There are no genuine issues of material fact in dispute. For the reasons stated in the accompanying Memorandum in Support of Plaintiffs' Motion for Partial Summary Judgment and in Opposition to

Defendants' Motion for Partial Summary Judgment, and supported by the accompanying Declarations of Jonathan Hafetz and Melissa Goodman, plaintiffs are entitled to judgment as a matter of law on these claims.
