

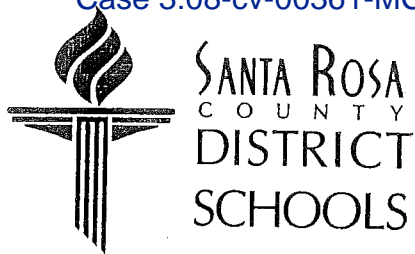

In a meeting at Pace High School with Lewis Lynn, Robert Freeman, yourself and me you gave a narrative of an event that took place on 1/27/09. You shared that you are, and were at the date of this incident, aware of the court injunction and aware that this type of action is not permissible under the injunction. You also shared that your action was not intentional in circumventing the court order. This letter is a follow-up to a meeting with you on Monday, February 24th regarding your actions at the School Related Employee of the Year (SREY) Banquet on Friday, February 20, 2009. You as a representative of the Santa Rosa School Board, employed at the Berryhill Administrative Complex, and having been informed by Judson Crane, Director of Purchasing and coordinator of the SREY event, that the SREY activity was a Santa Rosa School system event, under the court order, as explained by the School Board attorney, a prayer could not be given either by an employee or a non-employee. As an employee, you had no authority to use your position to provide an opportunity for a non-employee, your husband, to give a prayer. By doing so, Santa Rosa School district has been exposed to potential liability for violating the court's order.

Accordingly, you are directed to take no similar action in the future, not withstanding your personal feelings.
