Dear Judge Hellerstein:

For the reasons stated in the enclosed ex parte letter from John H. Durham provided for the Court's in camera review, we write to advise the Court that Mr. Durham withdraws his objection to paragraph 4 of the Court's April 20, 2009 Order. The enclosed letter is submitted ex parte because it contains details regarding the status of his investigation, which is still ongoing. We will work with Plaintiffs on a proposed schedule for the production of the information contemplated by paragraph 4 of the Order.

We also note for the Court that the Central Intelligence Agency has documents responsive to the subject matter identified in paragraph 4 of the Order that fall outside the date range provided in the Order; namely, April 1, 2002 through June 30, 2003. Mr. Durham may have objections to the production of documents created outside the date range specified in the Order. Mr. Durham is prepared to supplement the record as needed to the extent the Court amends the dates identified in paragraph 4 of the Order.
