#### **DECLARATION OF JERRY YOUNG**


- 1. My name is Jerry Young.
- I am over 18 years old, a United States citizen, and a resident of Lee
   County, Mississippi.
- I was convicted of armed robbery in the Lee County Circuit Court on or about December 18, 1980.
- 4. On August 26, 2008, I attempted to register to vote in the November 2008 presidential election in Lee County. I went to the Circuit Clerk's office in Tupelo and asked to be registered to vote in the November presidential election. I told the clerks I had previously tried to register for the general elections but was turned down because I have a felony conviction. I was told that I could not register to vote in the November

2008 presidential election and would have to first get my voting rights restored through the legislature before I could be eligible to vote in that election.

5. I wish to vote in the November 4, 2008 presidential election, but am unable to do so because neither the Mississippi voter registration application form nor the federal voter registration application form allow me to register only for the presidential and vice-presidential federal election.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.


- My name is Christy Colley.
